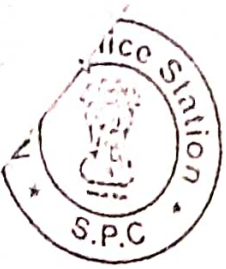

Sir,

With due respect, I am producing herewith 01 (One) arrested accused person named Rajjak Md (32), S/o- Kashim Md. Of Amaidighi, Fulbari, PS- NJP, Dist- Jalpaiguri under arrest. The ground of arrest duly been communicated with him and the following articles under seizure:-

- (i) 01 (One) Improvised small fire arms one shooter measuring 23 cm in length Approx including its 13 CM barrel with one trigger, striking hammer, striking pin in working condition Marked as "Exhibit-"A".
- (ii) One live ammunition (loaded) marked as Exhibit-"B"

I, ASI Khagen Barman of NJP PS, SPC do hereby lodge this written complaint against the above noted arrested accused person. In this regard, I beg to report that today i.e. on 14.12.2024 20.25 hrs, received a secret information that one person is loitering at near Mahananda Barrage under New Jalpaiguri PS, Dist- Jalpaiguri with improvised fire arms and ammunition to deliver the same to his designated customer. Accordingly, I informed the matter to you and as per your direction at 20.35 hrs myself along with C/452 Uttam Dey, C/152 Abdul Kayum Mia, VP/13 Jamrul Islam all of NJP PS, SPC left for Mahananda Barrage under PS-New Jalpaiguri PS, Dist- Jalpaiguri with investigation kit to work out the information in hand by Govt. vehicle. At about 20.55 hrs, we reached at the spot i.e. Mahananda Barrage and was waiting for the targeted person. At about 21.45 hrs as indicated by the source we are able to apprehended one person. On being asked he disclosed his identity as noted above. As per source information, that he was possessed improvised fire arms and ammunition. Hence, immediately I searched the above noted detained person and found (i) 01 (One) Improvised small fire arms one shooter measuring 23 cm in length Approx including its 13 CM barrel with one trigger, striking hammer, striking pin in working condition Marked as "Exhibit-"A" and (ii) One loaded live ammunition marked as Exhibit-"B". He exclusively possessed improvised fire arms and live ammunition illegally. On demand he failed to produce any document in support of the said improvised fire arms and live ammunition which has been found from his possession. On further interrogation he stated that he came to Mahananda Barrage under New Jalpaiguri PS, Dist- Jalpaiguri to deliver the same to his designated customer for his wrongful gain. Thus when his involvement in carrying and possessing illegal fire arms and live ammunition was established, I seized that improvised fire arms and 01 (One) round of live ammunition which was loaded in the fire arms under proper seizure list duly signed by him as well as by available witnesses. The whole processes of search, seizure, label and arrest was made in between 21.50 hrs to 22.15 hrs on 14.01.2024. Accordingly, I, arrested the apprehended accused person after issuing memo of arrest informing them about the ground of arrest.

Under the above noted facts and seizure of incriminating articles, there is strong reason to believe that the accused person named Rajjak Md (32), S/o- Kashim Md. Of Amaidighi, Fulbari, PS- NJP, Dist- Jalpaiguri is desperate and dangerous in nature, as he was carrying the said fire arms for sell purpose.
