In producing herewith four (04) arrested accused persons namely (i) Md. Samaj (19) S/O Md. Sariful of Mitagara Biswas Colony, PO+PS-Matigara, Dist-Darjeeling (ii) Md. Ali (19) S/O Mofijul Alam of Lelin Colony, PO+PS Matigara, Dist. Darjeeling (iii) Md. Imamuddin (23) s/o Md. Hajrat Hussain of Matigara Biswas Colony, P.O+ PS Matigara, Dist. Darjeeling (iv) Golu Mahato @ Amit (20) S/O- Amarjit Mahato of Binay Krishna Pally, Patiramjote, PS-Matigara, Dist-Darjeeling and (arrested u/s- 41 Cr.P.C) along with following seized articles viz:

- (1) One iron made rod measuring 16 inch (approx) and one torchlight seized from the possession of Md. Imamuddin holding in his right hand.
- (2) One iron made adjustable wrench measuring 17 inch (approx) seized from the possession of Md. Samaj which was kept concealed on his back. .
- (3) One iron made 'Knife' measuring 12 inch (approx) including plastic butt seized from the possession of Golu Mahato @ Amit which was kept on his back.
- (4) One iron made 'Kukri' measuring 13 inch (approx) including wooden butt seized from the possession of Md. Ali which was kept on his back,

I, ASI Pema Darjee Sherpa of Matigara PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted accused persons and others to the effect that today on 17.01.2024 at 01.25 hrs received a source information that 12/13 youths had assembled at Chandmoni near Chamta Bridge under Matigara PS with a view to commit docaity in a house at Pati Colony area under Matigara PS.

Subsequently, after sharing the information with Officer In charge and as per his direction, I along with other officer and forces of Matigara PS, SPC, left for above noted place to work out the information.

At about 01:45 hrs after reaching at Chandmoni near Chamta Bridge under Matigara PS, I met my source and being pointed by the source we started walking towards the dense bushes near Chamta bridge and started cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and were about to move from the spot.

Seeing the Police team approaching towards them they tried to flee away, but on hot chase we managed to apprehend and detain the above noted four (04) persons along with seized articles as mentioned above. However, the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation all the accused persons disclosed their identity as noted above and they admitted that they had assembled there and was making preparation to commit docaity in a house at Pati Colony area under Matigara PS.

I thereafter, seized the above noted deadly weapons under proper seizure list in presence of witnesses duly acknowledged by the accused persons. The whole seizure was made in between 02:15 hrs to 02:45 hrs. Thereafter, I arrested the above detained accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons.

I accordingly brought the arrested accused persons along with seized article at Matigara Police Station for further investigation. In course of interrogation, it could be revealed from the arrested accused persons that they along with their fellow associates were gathered at Chandmoni near Chamta Bridge for making preparation to commit docaity in a house at Pati Colony area under Matigara PS.

I therefore pray before you that a specific case may kindly be initiated under proper section of law against the above noted accused persons namely (i) Md. Samaj (19) S/O Md. Sariful of Mitagara Biswas Colony, PO+PS-Matigara, Dist-Darjeeling (ii) Md. Ali (19) S/O Mofijul Alam of Lelin Colony, PO+PS Matigara, Dist. Darjeeling (iii) Md. Imamuddin (23) s/o Md. Hajrat Hussain of Matigara Biswas Colony, P.O+ PS Matigara, Dist. Darjeeling (iv) Golu Mahato @ Amit (20) S/O- Amarjit Mahato of Binay Krishna Pally, Patiramjote, PS-Matigara, Dist-Darjeeling and others and arrange for its investigation.
