Dear Sir,

I Anandita Lama, resident of Lake Town would like to inform you that Shyamol Biswa Sharma tenant of Indranil Bhownick of Lake Town along with his accomplices named Subhankar Mahajan, son of Uttam Mahajan of Gate Bazar NJP and others were shouting loudly and abusing us, calling "Nepali Suwar", "aira gaika maal," "Tinsukia party" and challenging us to come out and giving us death threat & that too at 1:30 am which made me wake up to notice what is happening outside. Seeing this dangerous situation I immediately contacted N.J.P police. The police van came immediately and arrested ~~red~~ handed only one person called Subhankar Mahajan but the main accused and others fled. So the police seized his vehicle and we personally visited thana at 2 am and filed a written complaint and came back home.

But once again I was shocked to see him at 8 am in front of my residence and shouting "Nepali Suwar" come out and life threatening us. So helplessly I contacted N.J.P police and the police came to nab him from his rented house next door but was not there and had fled the scene.
