Respected sir,

I, Smt. Bela Sharma, Wife of Manoj Kumar Sharma Sharma, resident of Sashtri Nagar, Ward No.41 of S.M.C. P.O. Sevoke Road, P.S. Bhakti Nagar, Dist. Jalpaiguri, would like to inform you the following facts:-

1. That in the month of August 2004 my marriage was solemnized with Manoj Kumar Sharma, and after marriage I have been residing at in my inlaws house at above mentioned address and my father-in-law and mother-in-law.
2. That soon after our marriage, my husband **Manoj Kumar Sharma** his father namely **Om Parkash Sharma**, his mother **Gouri Devi Sharma**, his sister **Lila Paswan** started torturing me both physically and mentally. They abuse me in filthy and offensive languages almost each and every day without any reason. My husband after drinking alcohol use to physically assault me by fists, blows, and by kicks, but I digested all their torture in the hope that after some passage of time they would change their nature but till today they are of same nature and character.
3. That since 6 months my husband and my aforesaid in-laws torture upon me increased rapidly. My husband in every night use to come late at night and on asking use to assault me mercilessly on the instigation of his

father, mother and sister and throw my all cooked food which I prepared for myself and my children and even my husband many time assaulted my daughters saying that they are burden on him and as I have not brought a single penny from my father's house then how come he will bear the marriage expenses of my daughter and every night he tells me and my daughters to leave the house or die by committing suicide and on 13.01.2024 night at about 10 p.m. my husband mercilessly assaulted me and seeing this my daughter namely Priyanka Sharma rushed to save me at that time my husband with intention to kill my daughter hit her on her head with iron rod as a result her skull was fractured and blood was oozing out from her head. She was then treated and my husband requested me to not lodge any complain against him and asked for apology.

4. That yesterday i.e. on 16.01.2024 at about 10 p.m. my husband, his sister, mother and father again assaulted me with the view to drive me and my daughters out from my in laws house. They assaulted me for about 10 to 15 minutes and told to leave the house and when I denied then my husband and sister in-law strangulated me very hard with intention to kill me and thereafter my husband and my in-laws put a spoon in my mouth and pushed me by their hands so that I cannot take breath and may die by suffocating. Seeing the situation my tenants raised hue and cry and para people gathered there on the spot and saved me from their clutches.

If my neighbours had not saved me then I would have definitely died out of suffocation for putting of spoon in my mouth.

5. That due to such strangulation and of forcefully putting spoon in my mouth I had received severe injury in my neck and throat and I have not

been able to eat drink since then and am unable to swallow anything at present.

6. That I have been treated at Siliguri S.D. Hospital on 17.01.24 for the injuries caused by such assault.

I, therefore, request to you to kindly take necessary legal action against the aforesaid persons for the commission of the aforesaid offences by them upon me.
