Siliguri, P.O. Siliguri Town, District-Darjeeling, PIN-734004, would like to inform you thatI am the owner of a 2∕two) storied building being constructed by my husband in land measuring 2(two) katha purchased by me and 1(one) katha purchased by my father in R.S. Plot No. 3593 and 3595, situated at Babupara, Silikuri, within Ward No. XXVI under the Siliguri Municipal Corporation, by Vinue of a Deed of Sale being No. 5074 for the year 1987, for land measuring 2(two) katha, executed in my name by one Sri/ Bikash Ghosh, and Deed No.5073 for the year 1987, for land measuring 1(one) katha, executed in the name of my father Nital Chandra Chosh (since Deceased) by Sri. Bikash Ghosh. Thereafter I along with my husband started residing in the ground floor of the 2(two) storied house and obtained electricity connection in my name from the then West Bengal State Electricity board and also started paying Municipal Holding Tax issued in my name and my father's name. Due to some differences with my husband after the birth of my daughter Anushree Ghosh in the year 1992, my husband left me in this house and went back to Dhupguri and I being a poor helpless lady finding no other alternative gave the first floor of the building on rent and started receiving rent on my bank account, which is my only livelihood since then and I have raised my daughter by means of the monthly rent I receive. In the Year 2011, I along with my daughter temporarily started residing at Kolkata at the flat of my mother, for providing better education for my daughter but I keep visiting my house in Siliguri regularly for paying the electricity bills and other maintenance charges.

Recently in the 2<sup>nd</sup> week of December,2023, while I was in Kolkata, busy in making arrangements for the wedding of my daughter in the month of February, 2024, I received a Caveat Notice filed by my brother Sri Subal Ghosh in the court of Ld. Civil Judge(Senior Division) at Siliguri and Ld. Civil Judge(Junior) Division court at Siliguri against my 2(two) storied house. Thereafter, upon consulting my Lawyer in Siliguri, I came to learn that my brother has fraudulently filed a partition suit with respect to my 2(two) storied house before the Ld. Civil Judge Senior Division Court at Siliguri. Upon having such knowledge, I booked tickets for today i.e., 16.01.2024 in Vande Bharat Express and after reaching N.J.P. today at about 1.32 pm I went to my house at about 2.30 pm today, where I was shocked to find that Sri Saptak Ghosh who happens to be the son of my brother Sri Subal Ghosh and Smt. Minakshi Ghosh wife of Saptak Ghosh, has entered into my room breaking the lock of the entrance door and they have even ransacked the furniture and other household items and/or articles

belonging to the me and my daughter and found that the Cash of Rs.50,000/-(Rupees Pifty Thousand only) and Gold Ornaments which I had kept in that room, are all missing and as I started yelling, said Saptak Ghosh pushed me out of my room by pulling my hair and even tried to disrobe me and threatened me that if I don't leave the house immediately, he will kill me.As I started yelling, said Saptak Ghosh and Minakshi Ghosh threatened me with a knife to kill me and as I am all alone, no one will help me. As such some how I managed to rescue from the place saving my life from the hands of Saptak Ghosh and Minakshi Ghosh and somehow managed to check-in to a hotel at Sevoke Road today after putting a new pad lock on the entrance of my room.

I being a poor helpless lady having no one to help me over here and having no other alternative, approach before you with folded hands to save my life from Saptak Ghosh son of Subal Ghosh and Minakshi Ghosh wife of Saptak Ghosh, and take immediate action as per law against Saptak Ghosh and Minakshi Ghosh for breaking into my house at Babupara, Siliguri and misappropriating my gold ornaments and eash of Rs.50,000/- in my absence and applying force on me for evicting me from my house. Your early action in this regard in highly solicited.
