Dear Sir,

I, Mrs. Priyanka Majumder, daughter of Late Prosanto Majumder, resident of Rabindra Sarani Main Road, Bakultala More, P.O. Rabindra Sarani, P.S. Siliguri, Dist. Darjeeling - 734006, in the state of West Bengal, would like to bring to your kind notice the following matters: -

1. That I am running a Pet Shop in the name and style of 'Jennelie's Pet Shop' in the ground floor of my house located at Rabindra Sarani Main Road, Bakultala More, P.O. and P.S. Siliguri, Dist. Darjeeling - 734006, West Bengal.
2. This is to inform you that on 10/01/2024 around 11:00 AM a customer named Subhojit Mandal accompanied by his friend (Sudeshna Majhi) visited my shop seeking treatment for his GSD puppy dog. While I was temporarily away from my shop to attend some tasks in my kennel which is on the fourth floor of the said building, the said Subhojit Mandal managed to enter the restricted area behind the counter without my consent, knowledge or permission and gain unauthorized access to the counter area.
3. That unfortunately, I was not aware of this intrusion until the end of the day when I closed the shop and conduct a thorough examination of the day's sales records, I discovered a significant discrepancy in the total sales for the day. The calculated total did not match the actual sales, when I asked my staff about this incident way the amount is mismatching with the whole day sales, then she confronted me that the

said Subhojit Mandal in my absence entered into the counter area and sat on my chair, leading me to suspect that a theft had taken place during that visit.

4. That it is evident that an unauthorized person gained access to my shop's counter area and may have committed theft and I am concerned about the financial loss incurred as a result. I am extremely concerned about this situation, and I believe it requires immediate attention and investigation.

The following information is provided for your reference:

Date and Time of Incident: 10/01/2024, approximately 11:00 AM

Description of Individuals Involved:

- a. Customer – Subhojit Mandal
- b. Customer's Friend – Sudeshna Majhi

Nature of Incident: Theft and unauthorized access to the counter area.

Details of Stolen Items or Missing Funds: Cash amount of Rs. 6,000/- approximately.

Any Witnesses: Sreyoshi, Chetan Raj Roy and Prosenjit Dey.

5. That I kindly request your prompt assistance in investigating this matter and apprehending the said Subhojit Mandal and Sudeshna Majhi may be responsible for this theft as except them, nobody had entered into my counter area. I am willing to cooperate fully with the police department and provide any necessary information or to aid in the investigation. I have attached all the relevant details about the said individual for your reference.
6. That I am requesting you to take strict action and launch a thorough investigation and take necessary action to the persons those who are involved in this theft incident. We are willing to cooperate with the police in every possible way to ensure that the culprit may behind the bar for this unlawful act and conduct.
