Sub: FIR in respect to Pilferage of Electricity

Sir,

I do hereby lodge a complaint empowered by the Electricity Act, 2003, read with further amendments that Mr. Akash Chowdhury (User), S/O- Dulal Chowdhury, Babla Apartment, Rabindra Nagar (Near Habu Flour Mill), Ward No.- 21, P.O. - Rabindra Sarani, PS- Siliguri, District- Darjeeling, PIN- 734006 (Consumer ID: 400171191), has committed Theft of Electricity under section: 135(i)(a) & 138(b) of the Electricity Act, 2003, read with further amendments for the Domestic purpose as stated here under.

On 17.01.2024 at about 13:35 hours, I, Sri Sourav Paul, DE (E) & Station Manager, Subhaspally CCC, WBSEDCL, along with 1. Mr. Pranab Sikdar, Special Officer, S&LP unit, Darjeeling Region Office, WBSEDCL & 2. Mr. Arnab Ray, J.E. (E) (Grade-II) & 3. Mr. Biswajit Biswas, Contractual Staff of LT Mobile Van, attached with Subhaspally CCC, WBSEDCL, entered into the Domestic premises of Mr. Dulal Chowdhury, S/O- Binay Krishna Chowdhury, Babla Apartment, Rabindra Nagar (Near Habu Flour Mill), Ward No. - 21, P.O. - Rabindra Sarani, PS- Siliguri, District- Darjeeling, PIN- 734006 (Consumer ID: 400171191), in order to inspect the service line incoming & leaving the meter as well as Supervisory Checking purpose.

During inspection it has been found that the aforesaid accused, Mr. Akash Chowdhury (User), S/O- Dulal Chowdhury, Babla Apartment, Rabindra Nagar (Near Habu Flour Mill), Ward No.- 21, P.O. - Rabindra Sarani, PS- Siliguri, District- Darjeeling, PIN- 734006 (Consumer ID: 400171191), was consuming Electricity dishonestly in unauthorized manner by Unauthorized Reconnection of the 'Deemed Disconnected' service connection having Consumer ID: 400171191 & Meter No.: L1684534 which was disconnected on 09.09.2022 due to having outstanding dues of electricity of Rs. 4,648.00 (excluding LPSC). Moreover, the last meter consumption up to which billing was raised is 15771 kWh. And, during inspection on 17.01.2024, the service connection was found 'Physically Live' i.e. the accused person was found consuming electricity through that meter at that earmarked Domestic premises for Domestic purposes & the aforesaid energy meter was found 'performing normal' having last reading of 17050 kWh during seizure of the meter. Thus the service connection was used in unauthorized manner & WBSEDCL incurred huge amount of loss in revenue.

As the unauthorized use had been detected I immediately with the help of my Technical staff disconnected his Service Connection and seized one number Energy Meter having device SI No.: L1684534, make: Landis-Gyr, Rating: 240V, 5-30A, 50Hz, 3200 imp/kWh (L.R.: 17050 kWh) connected with some portion of Incoming & Outgoing wires which have been used for Unauthorized reconnection of the 'Deemed Disconnected' service connection (Consumer ID: 400171191) & consuming electricity dishonestly in unauthorized manner at the aforementioned Domestic premises for the Domestic purposes under a proper seizure list as well as the seized articles were properly packed, labeled and sealed at the spot after observing necessary formalities in presence of the Inspection Team Members & Witnesses & the Accused Person himself. The inspection team members left the aforesaid premises at 14:05 hours on the same day after observing all formalities.

*So the accused Mr. Akash Chowdhury (User), S/O- Dulal Chowdhury, Babla Apartment, Rabindra Nagar (Near Habu Flour Mill), Ward No.- 21, P.O. - Rabindra Sarani, PS- Siliguri, District- Darjeeling, PIN- 734006 (Consumer ID: 400171191), has committed Theft of Electricity under section: 135(i) (a) & 138 (b) of the Electricity Act, 2003, read with further amendments for the Domestic purpose.

So I request you to take cognizance against the aforementioned accused person on this matter and consider this complain as FIR to initiate further necessary action from your end.
