Sir,

With due respect, in producing herewith one accused person namely Annu Singh (34), S/O-Birendar Singh of Kolkata Road Bhujipani, P.S- Bagdogra, Dist.- Darjeeling under arrest along with seized article as follows :-

(i) One iron made sharp cutting weapon called as Hasua, measuring approx 19 inches including approx 7 inches wooden Butt, one side sharp and head slightly carve.

I, PSI Adreesh Ray Of Bagdogra PS under Siliguri Police Commissionerate do here by lodged a written complaint against one Annu Singh (34), S/O- Birendar Singh of Kolkata Road Bhujipani, P.S- Bagdogra, Dist.- Darjeeling to the effect that today on 18/01/2024 while I along with C/283-Dani Barman and CV/923-Pandit Nagesia were performing evening mobile Van duty vide Bagdogra P.S. GDE No- 844 and MCC No-170/24 Dated-18/01/24 at about 19.55 hrs I received information from duty officer that one person is roaming around in Bhujipani Kolkata road area carrying sharp cutting object (Hansua) in hand in an aggressive manner and attacking passerby in the locality. Accordingly I along with other officer namely SI Binup Mahato, SI Uday Chakarabarty and force rushed to the spot immediately. On arrival at the spot at about at 20-35 hrs Bhujipani Kolkata Road under Bagdogra PS we found that the above noted person was roaming with a Sharp cutting Hansua in hand and attacking people nearby and out of fear local people are running here and there. Seeing this when we tried calm him down the alleged person started throwing stone towards police van due to which Mobile Van having no-WB-77-4082 badly got damaged thus prohibiting the on duty Police personnel to perform their duty. Thereafter when we tried to restrain him, the alleged person ran towards us to attack and strike with the said "Hasua" over the head of SI Uday Chakarabarty, but he managed to save himself by his hand, as a result he received cut injury on the finger of right hand. When I along with other officer and force again tried to restrain him the alleged person also attacked us with that "Hansua" as a result of which I along with C/283 Dani Barman also received injuries. At last with the help of the local people we apprehended him with said Hasua. As such I arrested him U/S-41 CrPC issuing memo of arrest and inform his ground of arrest and seized one iron made sharp cutting object called as Hasua as per proper seizure list. The seizure was made in between 21-15 hrs to 21-25 hrs.

Therefore I pray before your honor that a specific case may kindly be started against Annu Singh (34), S/O-Birendar Singh of Kolkata Road Bhujipani, P.S- Bagdogra, Dist.-Darjeeling as per proper sections of law and arrange for its investigation.
