This is to inform you that a vehicle (Registration Number AP39T3159) has made a collision with 8 Meter long LT PCC Pole of WBSEDCL located at Raja Ram Mohan Roy Road, Near Bandhan Bank today on 18.01.2024 at about 5 AM in the morning, which has damaged the pole severely, resulting in which power supply in that area to some extent got disrupted. The site has been inspected and reported by Sri Sudipta Moitra, L.M. of Hakimpara Customer Care Centre.
