Sir,

In producing herewith five (05) five arrested accused persons namely (i) Md. Mustak (M-21) S/O Lt. Md. Amin of Jhankar More, Koila Dipu, PO+PS-Siliguri, Dist. Darjeeling, (ii) Sunil Tamang @ Zabbar (M-28) S/O Shankar Tamanag Debidanga, Kalabari, PO-Champasari, PS-Pradhannagar, Dist-Darjeeling, (iii) Arun Biswakarma (M-20) S/O Lt. Raju Biswakarma of Darjeeling More Gas Godown, PO+PS-Matigara, Dist- Darjeeling (iv) Ujjwal Chettri (M-32) S/O Udai Chettri of Pokrebong, PO+PS- Sukhia, Dist- Darjeeling and (v) Rajesh Kumar (M-35) S/O Rameshewar Kumar of Bara Mechia Busty, PS-Jaigoan, Dist- Alipurduar under arrest and the following articles seized articles viz:

- I. One iron made sword measuring 31 inch (approx.) including wooden butt seized from the possession of Md. Mustak which was kept concealed on his back side.
- II. One iron made sword measuring 34 inch (approx.) including wooden butt seized from the possession of Sunil Tamang @ Zabbar which was kept concealed on his back side,
- III. One iron made 'Khukri' measuring 17 inch (approx.) seized from the possession of Arun Biswakarma which he was carrying on his left hand.
- IV. One iron made weapon locally called as "Bhojali" measuring 18 inch (approx.) seized from the possession of Ujjwal Chettri.
- V. One iron made Sharp cutting steel made knife measuring approx. 8 inches (approx) in length seized from the possession of Rajesh Kumar.

I, SI Agen Lepcha of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted 05 (five) arrested accused persons namely ((i) Md. Mustak (M-21) S/O Lt. Md. Amin of Jhankar More, Koila Dipu, PO+PS-Siliguri, Dist. Darjeeling, (ii) Sunil Tamang @ Zabbar (M-28) S/O Shankar Tamanag Debidanga, Kalabari, PO-Champasari, PS-Pradhannagar, Dist-Darjeeling, (iii) Arun Biswakarma (M-20) S/O Lt. Raju Biswakarma of Darjeeling More Gas Godown, PO+PS-Matigara, Dist- Darjeeling (iv) Ujjwal Chettri (N-32) S/O Udai Chettri of Pokrebong, PO+PS- Sukhia, Dist- Darjeeling and (v) Rajesh Kumar (M-35) S/O Rameshewar Kumar of Bara Machia Busty, PS-Jaigoan, Dist- Alipurduar and another 05/06 unknown involve accused person to the effect that today on 20.01.2024 at 00:15 hrs received a source information that 11/12 youths have assembled under Mahananda Bridge near Samshan Ghat with deadly weapons and making preparation for committing dacoity in a house at Coolie Para. Accordingly, I informed the matter to the I/C, Pradhan Nagar PS and diarized the fact in General diary vide Pradhan Nagar PS GDE No 1044 dated 20.01.2024. After getting the permission from the I/C, Pradhan Nagar PS I along with ASI Monoj Kr Roy, C/1411 Ashok Roy, C/1413 Sujit Sarkar, C/1415 Chandan Basak and C/1416 Dilip Barman all of Pradhan Nagar PS left for Coolie Para to verify the veracity of the information. Under these circumstances any search warrant or authorization for search cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender. On the way to Samshan Ghat I requested night RT van officer SI Satish Ruchal and PSI Bhiswadeb Barman to come under Mahananda Bridge to accompany with us for holding raid under Mahanahda Bridge. At about 01:05 hrs we reached near Mahananda Bridge and after a few time SI SI Satish Ruchal and PSI Bhiswadeb Barman along with their forces arrived at the spot. I accordingly contact with my source and as pointed by the source we noticed that 11/12 persons were assembled in a dark place under Mahananda Bridge near Samshan Ghat and were whispering in a very low voice. Then we cordoned the place very carefully with a strong reason to believe that they were preparing to commit some cognizable offence and started walking towards them. But seeing police personnel approaching towards them they tried to flee away. However on hot chase we managed to apprehend above noted five (05) accused persons with deadly weapons in their possession but 05/06 persons managed to flee away from the spot taking the advantage of darkness and open place. On being asked they disclosed their identity as noted above. On interrogation they give different statement in different time and failed to give any satisfactory reply for their presence in the middle of night with deadly weapons. Finally they disclosed that they along with their associates had assembled there and were making preparation for committing dacoity in a house at Coolie Para area. Accordingly, I seized the above mentioned weapon of offence from their possession under proper seizure list duly signed by the witnesses and acknowledged by the accused persons and subsequently arrested them under proper memo of arrest and observing all the formalities of arrest. I accordingly brought all the five arrested accused persons along with seized article at Pradhan Nagar Police Station for further investigation. During interrogation it could be revealed from the arrested accused persons that they were gathered there and making preparation for committing dacoity in a house at Coolie Para area.

Under the above noted fact and circumstances, I therefore pray before you that a specific case under proper section of Law may kindly be started against the above noted arrested accused persons namely (i) Md. Mustak (M-21) S/O Lt. Md. Amin of Jhankar More, Koila Dipu ,PO+PS-Siliguri, Dist. Darjeeling, (ii) Sunil Tamang @ Zabbar (M-28) S/O Shankar Tamanag Debidanga , Kalabari, PO-Champasari, PS-Pradhannagar, Dist-Darjeeling, (iii) Arun Biswakarma (M-20) S/O Lt. Raju Biswakarma of Darjeeling More Gas Godown, PO+PS-Matigara, Dist- Darjeeling (iv) Ujjwal Chettri (M-32) S/O Udai Chettri of Pokrebong, PO+PS- Sukhia, Dist- Darjeeling and (v) Rajesh Kumar (M-35) S/O Rameshewar Kumar of Bara Machia Busty, PS-Jaigoan, Dist- Alipurduar and others 05/06 unknown miscreants and arrange for its investigation.
