1. Prashanta Kumar Mahato, s/o- Mr. Dilip Kumar Mahato, Assistant Engineer and Station Manager, Milanpally CCC, WBSEDCL, do hereby lodge this complaint against **Mr. Mangal Seal** for unauthorized usage of Domestic Electric Connection having Con ID: 412093637, Meter No.: L1951036 for commercial purpose since last 1 year illegally by tapping from meter incoming and thereby liable u/s 135(1)(e) of Electricity Act, 2003.

On dated:18.01.2024, about 14:40 hours, I along with (i) Sri Pranab Sikdar, SO, Darjeeling Region, and other supporting staff of maintenance team visited the said premises for inspection. During inspection it was found that the consumer was using Domestic Electric Connection for commercial purpose (**Garment Shop styled as Mita Bastralaya**) illegally and unauthorisedly by tapping from meter incoming.

According, I issued notice and served a copy to the consumer present at site. As the unauthorized use of electricity detected, the service connection has been disconnected with removal of Copper wire and Fuse unit-32 Amp used for theft.

Mr. Mangal Seal committed an offence u/s 135(1)(e) of Electricity Act, 2003.

Hence, you are requested to lodge an FIR against the said consumer **Mr. Mangal Seal** and arrange for its investigation
