I, Rakhi Choudhury, Wife of Manoj Choudhury, resident of Stalin Nagar, Road No. 2,
P.O+P.S. Bagdogra, Dist- Darjeeling, do hereby solemnly affirm and declare as follows:-

1. That yesterday i.e. 18.01.2024 at about 8:30 p.m. when I returned home from Bagdogra Bazar after purchasing some grocery items, at that time on a lonely place at a lonely place Nitu Choudhury, Wife of Arun Chudhury of same locality alongwith two person whose name I cannot say all of sudden cane in front of me and started abusing me in filthy and offensive languages and on my protest said Nitu Choudhury and said two associates started physically assaulted me by fists and blows and kicks, they assaulted me for about 10 minutes, said Nitu Choudhury by showing me one big knife which she kept in her bag threatened me with dire consequences, said Nitu Choudhury with the help of her associates snatched Rs.3500/- from me.

It is to be mentioned here that said Nitu Choudhry is in relation with my husband and on her instigation and provocation my husband tortured me and live apart from me since 4 years and my husband continuously forced me to divorce him and tried to evict me and my son from his house, so that my husband and said Nitu Choudhury may live in my in-laws house with my husband as husband wife.

I, therefore, request you to kindly take necessary legal actions against Nitu Choudury and her two associates for the commission of aforesaid offenses against me.
