Sir,
I do hereby lodge a complaint empowered by the Electricity Act, 2003, read with further amendments that Mr. Mani Roy, S/O Late Manmohan Roy, Original Address: Puspa Abasan, East Vivekanandapally, S.M.C., Ward No.: 39, P.O. - Rabindra Sarani, PS- Bhaktinagar, District- Jalpaiguri, PIN- 734006, has committed Theft of Electricity under section: 135(i)(a) & 138(b) of the Electricity Act, 2003 read with further amendments for the Domestic purpose at the flat/apartment called 'Rabindra Neer' developed by him situated at Aurobindopally (opposite to Murari Mohan Primary School), S.M.C., Ward No.: 22, P.O. - Rabindra Sarani, PS- Siliguri, District- Darjeeling, PIN- 734006 (Consumer ID: 402458449) as stated here under.

On 19.01.2024 at about 15:30 hours, I, Sri Sourav Paul, DE (E) & Station Manager, Subhaspally CCC, WBSEDCL, along with 1. Mr. Pranab Sikdar, Special Officer, S&LP unit, Darjeeling Region Office, WBSEDCL & 2. Mr. Arnab Ray, J.E. (E) (Grade-II) & 3. Mr. Gopal Sarkar, Supervisor & Contractual Staff of LT Mobile Van, attached with Subhaspally CCC, WBSEDCL, entered into the Domestic premises (Flat/Apartment) called 'Rabindra Neer', Aurobindopally (opposite to Murari Mohan Primary School), S.M.C., Ward No.: 22, P.O. - Rabindra Sarani, PS- Siliguri, District- Darjeeling, PIN- 734006 (Consumer ID: 402458449) developed by Mr. Mani Roy, S/O- Late Manmohan Roy, Original Address: Puspa Abasan, East Vivekanandapally, S.M.C., Ward No.: 39, P.O. - Rabindra Sarani, PS- Bhaktinagar, District- Jalpaiguri, PIN- 734006, in order to inspect the service line incoming & leaving the meter as well as Supervisory Checking purpose.

During inspection, the aforesaid accused, Mr. Mani Roy, S/O- Late Manmohan Roy was found consuming Electricity dishonestly in unauthorized manner at 'Rabindra Neer', Aurobindopally (opposite to Murari Mohan Primary School), S.M.C., Ward No.: 22, P.O. - Rabindra Sarani, PS- Siliguri, District- Darjeeling, PIN- 734006 (Consumer ID: 402458449) by Unauthorized Reconnection of the 'Deemed Disconnected' service connection having Consumer ID: 402458449 & Meter No.: SF056941 which was disconnected on 09.09.2022 due to having outstanding dues of electricity. Moreover, the last meter consumption up to which billing was raised is 2038 kWh. And, during inspection on 19.01.2024, the service connection was found 'Physically Live' as well as consuming electricity through that meter installed in that earmarked Domestic premises for Domestic purposes (Common purpose for Flat /Apartment) & the aforesaid energy meter was found 'performing normal' having last reading of 12623 kWh during seizure of the meter. Thus the service connection was used in unauthorized manner because of which WBSEDCL incurred huge amount of loss in revenue.

As the unauthorized use had been detected I immediately with the help of my Technical staff disconnected the Service Connection and seized one number 3-phase, 4-wire Energy Meter having device SI No.: SF056941, make: Secure, Rating: 3x240V (415V), 5-30A, 50Hz, 1600 imp/kWh (L.R.: 12623 kWh) connected with some portion of Incoming & Outgoing wires which have been used for Unauthorized reconnection of the 'Deemed Disconnected' service connection (Consumer ID: 402458449) & consuming electricity dishonestly in unauthorized manner at the aforementioned Domestic premises for the Domestic purposes under a proper seizure list as well as the seized articles were properly packed, labeled and sealed at the spot after observing necessary formalities in presence of the Inspection Team Members & Witnesses & other local witnesses (the Accused Person was absent). The inspection team members left the aforesaid premises at 16:20 hours on the same day after observing all formalities.

So the accused Mr. Mani Roy, S/O- Late Manmohan Roy, Original Address: Puspa Abasan, East Vivekanandapally, S.M.C., Ward No.: 39, P.O. - Rabindra Sarani, PS- Bhaktinagar, District- Jalpaiguri, PIN- 734006, has committed Theft of Electricity under section: 135(i)(a) & 138(b) of the Electricity Act, 2003, read with further amendments for the Domestic purpose at the flat/apartment called 'Rabindra Neer' developed by him situated at Aurobindopally (opposite to Murari Mohan Primary School), S.M.C., Ward No.: 22, P.O. - Rabindra Sarani, PS- Siliguri, District- Darjeeling, PIN- 734006 (Consumer ID: 402458449).

So I request you to take cognizance against the aforementioned accused person on this matter and consider this complain as FIR to initiate further necessary action from your end.
