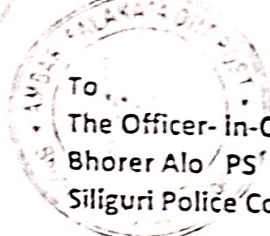

In producing herewith one accused person namely Pabitra Biswas (47yrs) Male S/o. Lt. Khagen Biswas of Shelterbari, PO. PS-Bhorer Alo, Dist- Jalpaiguri under proper section of law. along with the following seized articles as per proper seizure list:

1. 05(Five) Bottles Himalayan Gold Pet. 60 up County spirit each bottle Containing 600 ML.
2. 18(Eighteen) Bottles Zigar, 70 up country spirit each bottle containing 300 ML.

I, ASI Rabi Tamang of Ambari Falakata out post under Bhorer Alo PS/SPC lodged a written complainant against the above noted person to the effect that today i.e. on 20.01.2024 at 16:35hrs while myself along with force left for Evening raid Duty Vide Ambari-Falakata OP GDE No 645. Dated: 20.01.2024 in course of raid duty I received an information from my source that one Pabitra Biswas (47yrs) Male S/o. Lt. Khagen Biswas of Shelterbari, PO. PS-Bhorer Alo, Dist- Jalpaiguri, which is huge amount of liquor illegally for selling the same in the customer for his wrongful gain. Accordingly I informed to O/C Ambari Falakata out post about the information. As per his kind instruction I along with, 1. SI. PR Bhutia , 2. TC/693S S Roy, 3. TC/3936 S, Roy, 4. CV-001 Jaichand Roy all of Ambari – Falakata OP, Under Bhorer Alo – PS, SPC proceed to Shelterbari to work out the information. At 17:05 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at the Shop of one Pabitra Biswas (47yrs) Male S/o. Lt. Khagen Biswas of Shelterbari, PO. PS-Bhorer Alo, Dist- Jalpaiguri and recovered the above noted articles from the possession of above noted accused person namely one Pabitra Biswas (47yrs). On demand he could not produce any valid license/documents in support of said liquor. He become a nervous and admitted his guilt before us and stated that he sell the same in the customer since long for his wrongful gain. In presence of witnesses namely 1. Abhijit Majundar S/o. Lt. Ashim Majundar of Ambari Falakata PO Kamarvita PS Bhorer Alo, Dist- Jalpaiguri and 2) Pranab Chowdhury S/o. Lt. Balai Chowdhury of 09 No. Colony, Ambari, PO. Kamarvita, PS. Bhorer Alo, Dist- Jalpaiguri. Accordingly I seized the above noted articles from the possession of above noted accused person after preparing proper seizure list and took signature of the accused person and witnesses. The seizure was made between 17.25 hrs to 17:50hrs. And I arrested the said person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you a specific case may kindly be started against the accused person namely, Pabitra Biswas (47yrs) Male S/o. Lt. Khagen Biswas of Shelterbari, PO. PS-Bhorer Alo, Dist- Jalpaiguri under proper section of law.
