Respected Sir,

This is Nivedita Singh from Siliguri  
Darjeeling district (WB). My son Krishna Singh 9 yrs  
old of class 2<sup>nd</sup> who is student of SRI SRI Academy.  
On 30<sup>th</sup> June, Dance teacher beat Krishna Singh  
with his hand and Guitar in his Back bone  
from where his spinal cord got injured and  
immediately he got paralysed. His fault was  
that he got little tired while dancing.  
How such unprofessional teacher is hired  
by such a Big Sri Sri Management team. This  
incidents all happened within CCTV camera zone  
and when my husband Sachin Singh to entered to

School, he was told by Principal Mam Mrs Chandrima Pradhan that they will show the video. But they did not.

Incident happened in dance class at 10 am approx, but School Management informed my husband (Sachin Singh) at 1 pm. As our house is little far away from School, my husband reached at 1:36 pm. School Management did not provide my son any First-Aid and neither medical support. After forcing by my husband, they managed one vehicle after 5 hours they took to Neotia Nursing home. By the time his lower body was fully paralysed and breathing problems got difficult.

After 4 days of Krishna Admission (4th July) all management team of Neotia and took our sign in Bond that they will not treat Krishna Singh at high Risk. (During this time, School owner Mr. Naresh Agarwal was regularly connected with Dr. Jeewan Silwal and was asking all major reports. They both have good friendship, which proves that Mr. Naresh Agarwal <sup>did not</sup> keep the CCTV footage and must have deleted).

We paid all charges of Nestia Bill and Discharge sheet we shifted Krishna Singh on July at 7 pm for Delhi BLK Max Super Speciality hospital through Air Ambulance. Krishna was jully with such life support head to toe he was in medical equipments, and Catheters with all oxygen support, that was a horrible to see my son as Parents.

We got physically, mentally and emotionally harraned and spent more than 45 Lakhs to save my child. We are average middle class family, we both are only hope for our son. Since 8 months we are jobless begging money to save my kid's life.

At the time of School Admission, we paid donation of 5 Lakhs to School for Safety and Security of my kids.

For his treatment we sold our Gold, property and took loan from few family members and friends. We did Donation Campaign through MILAAP But not got enough Support.

Krishna Undergone Trecheostomy Surgery for  
Oxygen support. Sri Sri Academy is very Big  
name in our Country of Sri Ravi Shankar Vidya  
Mandir Foundation when they do Big Big talks,  
through Spirituality. We have mail to them and  
asked for financial help for Krishna Singh  
treatment, no one replied and <sup>not</sup> supported.

While Admission to School, Jale were told by  
Mr. Roshan Karki that School takes all the  
responsibility for Safety and Security of children,  
that is why, they charge high school fees and  
Donations.

On 11<sup>th</sup> Oct '2023, Mr. Nareesh Agarwal the  
Director and founder of Sri Sri Academy Sityum  
called on whats app. audio call to my husband  
from no. 9800006799 to 7001465342.  
at about 1:32 pm and threaten him not to  
make any complaint as they have good  
connections with Politicians and local Police  
and Anti Social elements. He said that  
all mails are useless and he is not
