Sir,

With due respect I Smt. Baby Banik, W/o- Sri. Subhankar Banik, at present residing at a rented house of Sri. Manoj Saha, of Suryasikha Sarani, Haider Para, Under the Police Station of Bhakti Nagar, Ward No- 39, Dist- Jalpaiguri. Being a lady with little education would like to draw your kind attention to the following effect that the aforesaid two person i.e., Rana Paul and Shekhar Kumar Singh in the month of October 2023 at about 05:30 PM came to our garment shop namely "DEEP DRESSES" situated at Haider Para near Haider Para Sabji Bazar, informed me one second hand flat is ready for sale at Lower Bagdogra, Dist-Darjeeling in Panchayat area being Plot No- R.S. 264(part), L.R. 613, Khatian No- R.S. 2/1. L.R. 1 and new 1918, J.L. No- R.S. 82 , L.R. 93, Touzi No- 91, Pargana- Patharghata, Measuring 1480sq.ft in the first floor of the three story residential building together with proportionate undivided share of land measuring 0.05 acres, and several times induced me to visit the said flat, accordingly on 20/10/2023 at about 10:30 AM I along with aforesaid two person visited the said flat wherein I saw a middle aged woman staying there and I asked the aforesaid two person "who is she?" then they informed me she is the owner/landlady of the said flat. It is to be noted that I knew the aforesaid two person/broker since last two years because they used to come nearby tea stall of my Garment Shop and previously the also helped me to purchase a car through Hero Finance as a broker. On 28/10/2023 at about 11:00 AM aforesaid two person came to our shop and induced me to purchase the aforesaid flat @Rs.60,00,000/- (sixty Lakh) and they also assured me that they will help me to take loan from Shriram Housing Finance, SF Road, Siliguri. On good faith I agreed to purchase the said flat and after bargaining the sale proceed was fixed on 4,700,000(Forty-Seven Lakh). Thereafter I entered in to an agreement for sale on 20/11/2023 with the landlady of the said flat and advanced Rs. 2 lakhs in cash out of 47 lakhs. The original copy of the said agreement lying with the Shriram Housing Finance, SF Road, Siliguri. Thereafter loan was sanctioned and Rupees Twenty-Eight Lakh and Fifty Thousand paid to the land lady of the said flat and rest of the amount paid to the landlady through net banking and cash transactions. It is further to be noted that the aforesaid two person also provided three numbers of Phone No- of Shriram Housing Finance, SF Road, Siliguri, namely- Biplab Mishra, Rajkumar Gupta and Prasant Das and they conducted everything like searching, preparation of sale deed etc. and at the time of registration I handed over Rs. 2.5 lakhs for the expenses of registration in cash in the hands of Shekhar Kumar Singh. After making payment on 15/12/2023 I went to Tara Pith along with my minor son namely Deepayan Banik at that time the aforesaid two person/broker in connivance with the land lady and their peoples tried to make false registration to stand another woman wearing face mask as purchaser of the said flat instead of me i.e., Baby Banik then I got a text message to my phone number regarding registration then and immediately I contacted with the Shriram Housing Finance, SF Road, Siliguri through phone and informed about the text message that I got and then the false registration of the said flat get stopped. Thereafter aforesaid two person/broker along with land lady and their peoples took apology from me and accordingly on 18/12/2023 I returned from Tara Pith and on 28/12/2023 sale deed was executed with the land lady of the said flat namely Madhuri Sarkar. At the time of registration, the son, daughter in law of the landlady and aforesaid two person/broker, persons of Shriram Housing Finance, SF Road, Siliguri and one Sanjay Ghosh were present there and out of them daughter in law of the land lady i.e., Sarmishta Paul the and

Sanjay Ghosh put their signatures as witness in the sale deed bearing Registration No- 9822 dated: 28/12/2023 the photocopy of the sale deed is annexed with this complaint as Annexure 1, (the original copy of the said deed is lying with the Shriram Housing Finance, SF Road, Siliguri), photocopy of the Net Banking along with Cash transaction/s is also annexed with this complaint as Annexure 2. After registration the personnel of Shriram Housing Finance, SF Road, Siliguri directed me to appear before their office on 29/12/2023 at about 11:30 AM for taking the key of the said flat accordingly I went there on 29/12/2023 for bring the key of the said flat and they took me in the said flat at lower Bagdogra after taking signature of me on a two written paper but I did not know the contents of the said paper but they did not handover the key of the said flat and again directed me to come after two days their office they will hand over the key of the said flat but surprisingly not only after two days but I several times visited their office as well as said flat but did not get the key of the said flat and several occasion and I also contacted with the aforesaid land lady and her son, daughter in law through phone to vacate the aforesaid flat but they flatly denied the same by saying that they do not know any Baby Banik if I again asked the said flat then she or her persons will kill me. My EMI is 33,686 per month that amount was duly paid by me in due time. The aforesaid persons i.e., as per the subject of my written complaint hatched up a deep-rooted conspiracy to cheat me or cheat my hard earn money from the very beginning and they also tried to committed the offence of forgery in the registry office for standing another woman in place of me as purchaser.

In view of above you are requested to look into the matter by taking appropriate legal action against the aforesaid persons as per law and save me.
