Sir,

I SMT. BEAUTI SEN , wife of Sri Paritosh Sen, residing at Samar Nagar, N.S. Road Champasari within ward No.46 of Siliguri Municipal Corporation. Would like to lodged this complaint before you to the effect that my husband SRI PARITOSH SEN along with me residing with our 4 (four) sons, viz. SRI PRASENJIT SEN, SRI BISWAJIT SEN, SRI AVIJIT SEN & SRI ANUJIT SEN in the above address for the last 36 (thirty-six) years.

Sir, subsequently my 3 (three) sons after marriage leave us one by one and our third son SRI AVIJIT SEN started living with us and used to take care of us.

Sir, thereafter my said sons constructed a house structure there from his own money also my husband & I gave him money for our better living and we have started living peacefully without my hindrance.

It is to be mentioned here hat during Covid-19 pandemic time my 3 (three) sob who left us for their own life came back and encroached in my property and forcefully evicted us from that pucca house duly constructed by my son, Sri AVIJIT SN and bond us to stay within the old Tin shaded structure.

Sir, both of we are Senior Citizen, the landed property also in the name of my husband, then how some outsiders can enter into and encroached our property and torture upon us.



**Sir, every day my 3 (three) sons along with their wives come and torture us mentally, physically. They lost my many goods, furniture & cut down tree forcefully.**

**Sir my third son, SRI AVIJIT SEN is very innocent. My other sons threatened him along with us for dire consequence and also threatened that they will implicate us in my criminal case. Every night became a night mare to us.**

**Sir, being a Senior Citizen we do not have any other alternative to find our another Shelter by leaving our own property and my third son, i.e. Sri AVIJIT SEN who has been maintaining us since long become depressed, disturbed and soon will become a patient due to torture by his brothers and sister in law. Sir, several times, we have lodged several complaints before the appropriate authority but nothing happened.**

**Sir, I therefore, request you to take immediate necessary action to evict those dangerous, inhuman elements by evicting them from the land of my husband and also by punishing them and do the needful from your ends of justice, so that both of us can take our last breath peacefully.**
