Respected Sir,

I, Kakuli Begum, Wife of Abdul Khalek, resident of Sayan Apartment, 28/7, M.N.K. Road, Near Airport Residency, 4 No. Mahajati Nagar, VTC: North Dumdum (M), P.O. Birati, P.S. Airport, Dist. North 24 Parganas, beg to report you the following facts:-

1. That I am the owner and possessor of homestead land measuring 4.15 Decimals, situated at Mouza - Kalam, J.L. No.76, Sheet No.1, L.R. Plot No.132, Holding No.692, P.S. Matigara, Dist. Darjeeling, butted and bounded as follows:-

North	:	Pitch Road;
South	:	Land and House of Pratihari
East	:	Land and House of Bengu Nayek (now deceased)
West	:	Land and House of Nagen Singha.

2. That the aforesaid land has been in my possession since the year 2005.

I constructed and raised boundary wall with iron gate in iron net framed. The said gate is made at the North-West side of my said land by me.

3. That I reside alongwith my husband at my above mentioned residence due to the study of my son.

4. That I have been paying tax to the Matigara-I Gram Panchayat regularly since 19 years for my aforesaid land. The Holding number of my said land is 692 issued in my name by the said Gram Panchayat.

5. That on 30.12.2023 at about 5:00 p.m. (i) Karju Nayek, Son of Late Bengu Nayek, (ii) Sarju Nayek, Son of Late Bengu Nayek, (iii) Modi Oraon, Son of Ghunsi Oraon, all are of Kalam Jote, P.O. Sushruta

Nagar, P.S. Matigara, Dist. Darjeeling illegally demolished and down my entire such front side iron net framed wall including the main gate and made a tir shaded bamboo pole structure on my aforesaid land for their wrongfu occupation of my said land for their wrongful gain.

The caretaker of my said land namely Suraj Rajat informed me the said incident over mobile phone immediately during the said incident. He also informed that he tried them to restrain them from doing so but all of them physically assaulted him by fists and blows and drove him out from there.

After getting such information I and my husband came here on 01.01.2024 and found such nature and condition of my said land committed by them as stated above.

6. That again on 02.01.2024 at about 10: a.m. (morning) me and my husband went to my said land. At that time they were there. Seeing us they about to assault us physically and threatened us by saying that they will murder us if claim they said land and I ever come to my said land anytime in future. Due to fear we left the spot and informed the whole aforesaid matter to the local respectable persons who tried to settle the matter so that I can get relief, but they did not come to sit in the meeting called by said local respectable persons. So delay is caused to lodge this F.I.R.

It is mentioned here that after coming here me and my husband are temporarily living in the house of Sri M.R. Deb, Bakery More, Chiria More, Near Durga Mandir, P.O. Kadamtala, P.S. Matigara, Dist. Darjeeling.

I, therefore, request you to kindly take necessary step against them for their commission of the aforesaid offence and also take remedial action so that such illegal structure is removed from my said land and the aforesaid person may not occupy my said land in any way any time in future.
