I, **RINKI BARMAN**, wife of Dilip Barman, resident of Vill. Kawakhali, Netaji Para, P.O. Sushrutanagar, P.S. Matigara, Dist. Darjeeling, would like to inform you that **DILIP BARMAN**, son of Sri. Lalit Barman is my legally married husband. A Hindu marriage was solemnized between us in the year 2006 as per hindu rites and customs by performing all the marriage ceremonies. Since then we have been residing together as husband and wife at his house at the above mentioned residential address i.e. Vill. Kawakhali, Netaji Para, P.O. Sushrutanagar, P.S. Matigara, Dist. Darjeeling. Out of wed-lock one girl child namely **MOUMITA BARMAN** (16 years) and one boy child namely **SHIVAM BARMAN** (14 years) took birth. Since our marriage my said husband use to torture me both physically and mentally and always uses slang, filthy and offensive languages towards me and his minor children in anyone's presence. He is a drunkard and consumes weed too on regular basis and after consuming either alcohol or weed he brutally assaults me and his minor children unnecessarily. He is an iron-welder by profession but he never spends his income in maintaining his family and fulfilling the basic necessities of his wife and children. In fact he every time denies to accept me as his wife. I had informed all this activities to his parents but they paid no heed. I tried to change his nature and character all these years but in vain. Today i.e. 28.01.2024 at about 2.00 P.M. when he came home from his work in a drunken condition he suddenly started saying that has no more love and affection for me and his children as he is in a relation with another woman and saying this he hold my hair-log and started to push me and my children out of our house. On my resist he became furious and started to assault me mercilessly on my persons by saying "**today I will kill you and your children and bury at the lawn of this house**" and threw several punches on my face. When I fell on the floor he tried to kill me by squeezing my throat. Seeing this when my children tried to rescue me from his hands he assaulted my children in response. On my screaming the local people entered our house and saved us from his hands. He threatened that he will kill all three of us within midnight. Thereafter I along with my children took shelter in my paternal house at Vill. Kalamjote, Because of his assault I suffered grievous injury on my left eye. At present I am under treatment.

I therefore, earnestly request you to kindly take necessary legal steps against my husband **DILIP BARMAN** and protect us as there is an anticipation of our life threat. I shall be highly obliged to you forever.
