I Smt. Manasi Biswas, w/o Sri Palash Biswas, resident of "ARUNADOY" Hyderpara Bazar, Satyajit Roy Sarani, P.O. Rabindra Sarani, Ward No. 39 Siliguri Municipal Corporation, P.S. Bhaktinagar, District Jalpaiguri, would like to inform you that on 10/09/2023 at about 20.30 hours my brother Sushanta Das (30 years), s/o Sri Dilip Kumar Das, was riding motor cycle bearing registration no. WB74AM 3196 in moderate speed on the right side of the road returning home from Sevoke road when he reached Hyderpara Bazar near Arambagh at that time one unknown ToTo came with full speed and in rush and negligent manner and collided with my brother motor cycle he had been fallen down and received grievous and serious injuries and then he admitted Siliguri District Hospital with the help of local people with very serious conditions and there after my brother shifted to North Bengal Medical College & Hospital for treatment and on 13/09/2023 he died in North Bengal Medical College & Hospital due to his grievous injuries. It is to be noted here that my brother was working as a Private Job at Ashrampara near Rajib More, P.O. & P.S. Siliguri, District Darjeeling. Due to his treatment and other works we had been unable to lodge F.I.R with in time.

Therefore, I prayed before you to take necessary steps for F.I.R. and investigate the matter do the needful accordingly.
