Sub: Theft of Gold ornaments & other personal belongings
of ASMI CHONDHURY

Respected Sir,

I humbly beg to inform you that my daughter ASMI CHONDHURY, student of BSW was staying at Aditya PG, Haider Para, Market Complex as paying guest since 07.08.2023. Aditya PG is run and owned by Shri Bijay Thakur and Smt. Gauri Thakur (8597906892, 9832375617)

On 12.08.2023 myself with my daughter left PG around 11:45 am for Sheeguri, our relative's place, and returned on 13.08.2023 around 5:45 pm.

On return it was found that lock of lower drawer of the cupboard provided by the PG owner was broken and gold made ornaments, Rs. 1500/- in 3 currency notes of 500/- and few cosmetics were missing, though the keys were taken by us along with vehicle going for the trip to our relative's house.

It was also learnt that MOHINI, roommate of ASMI had also left PG and on query over phone she informed that she was in Gangtok at that time. However, Mohini returned to PG on 14.08.2023 and she declined to know anything about the incident rather she scuffled on ASMI causing hurt to her person.

It was revealed/ found at that time that both the cupboards of ASMI & MOHINI could be opened by MOHINI'S set of keys and the same copy of keys were also with PG owner.

~~Next~~ ASMI was taken to doctor on 14.08.2023 after she was hurt by MOHINI and ASMI left Aditya PG on 15.08.2023 morning.

The entire incident leads me to lodge complaints about missing / theft of ornaments, etc, attack on person of ASMI and subsequent incidents and FIR against PG owner. I, therefore request your kindness to take necessary action accordingly.

Details of ornaments and other missing things and broken/damaged described below:

- (i) Neck chain ₹ 10,000/-
- (ii) Nose pin ₹ 1,200/-
- (iii) Finger ring ₹ 17,000/-
- (iv) 500/- X 3 ₹ 1,500/-
- (v) Cosmetics products ₹ 1,800/-
- (vi) A pair of spectacles ₹ 6,720/-
- (vii) Bracelet - ₹ 1,200/-
