Most respectfully, I, Bijoy Maheshwari, S/O. Late Kishan Lal Maheshwari, proprietor of M/S. Tanisha Marketing having its office & godown at Tarachand Sadan, 2<sup>nd</sup> Mile, Sevoke Road, P/O. Sevoke Road under P/S. Bhaktinagar, District Jalpaiguri would like to submit the following few lines for your kind consideration and necessary action please: -

1. That during the night of 27/28-01-2024 a theft has taken place in our said godown and the following valuable goods of brass have been removed from the godown and the approximate value of the goods is shown against each item: -

(a) Birla Brass FTA 1/2" X 1/2" = 4 (four) Box.	Rs.51,520/-
(b) Birla Brass FTA 3/4" X 3/4" = 3 (three) Box.	Rs.35,328/-
(c) Birla Brass MTA 1/2" X 1/2" = 4 (four) Box.	Rs.27,117/-
(d) Birla Brass MTA 3/4" X 3/4" = 2 (two) Box.	Rs. 53,580/-
(e) Birla Brass Elbow 1/2" X 1/2" = 3 (three) Box.	Rs.9,729/-
(f) Birla Brass MTA 2" = 2 (two) Box.	Rs. 22,853/-
(g) KRS Brass Elbow 3/4" X 1/2" = 5 (five) Box.	Rs.36,639/-
(h) A pollo Brass FTA 3/4" X 1/2" = 1 (one) Box.	Rs.41,760/-


Under the above facts and circumstances, you are requested to take cognizance on this complaint and please ensure that the perpetrators are brought to the justice & oblige.
