On dated: 25.01.2024, about 11:15 am, I along with Mr. Palden Lama, JE(E) and other supporting maintenance personnel visited the said premises while undergoing routine inspection. During inspection it was found that the consumer was using Domestic Electric Connection for construction purpose by breaking polycarbonate seal of meter and thereby by-

passing the metering circuit

According, I issued notice and served a copy to the consumer present at site. As the unauthorised use of electricity was detected, the service connection has been disconnected and and the energy meter was removed along with necessary arrangements used to draw unauthorised power from WBSEDCL network. Corresponding seizure list was prepared and served to consumer.

The contractual load of consumer is 1.08 kva and load found during inspection was 1.07 kva Smt. Hena Rani Ghosh committed an offence u/s 135(1)(a) of Electricity Act, 2003 Hence, you are requested to lodge an FIR against the said consumerand arrange for its investigation
