Respected Sir,

I Tarunnum Parveen w/o Rahul Kumar, resident of
Tumbajote Matigara, currently I am separated,
with my husband along with my two kids
on 18-8-23 and I have filed an FIR in women
PS which is attached with this GD.

Today (25-01-24) at around 11'o clock I had gone to
Siliguri court to meet up with my lawyer and called
her to meet. After I reached the court I was unaware
that my husband was watching me and looking
for a chance to threaten me. As soon as I saw him
he started abusing me and humiliating me about
my character in a very bad manner as I tried to
stop it, he in turn caught me and twisted my
right arm and wrist very painfully. I tried to get
rid of him but he threatened me to take back
all cases or he would murder me and kidnapp my
children. Soon I started shouting and the public
nearby came to my rescue. I called my brother
and sister from the court premises and I rushed
to the hospital with them as I was unconscious.
Its been almost 5 months I have been waiting for
Justice because I totally believe in Indian justice.
Sir this is a life threatening matter for me as I
don't have any guardian. Please take the matter
very seriously
