Sir,

In producing herewith four (04) arrested accused persons namely (i) Goutam Roy (M-26) S/O Kamal Roy of Champasari Anchal Govindanagar, PO- Champasari, PS-Pradhannagar, Dist. Darjeeling, (ii) Gobinda Roy (M-22) S/O, Kamal Roy of Champasari Anchal Govindanagar, PO- Champasari, PS-Pradhannagar, Dist. Darjeeling (iii) Uday Singh (M-18) S/O Sunil Singh of Middle Palash, PO- Champasari, PS-Pradhannagar, Dist- Darjeeling and (iv) Biru Saibo (M-24) S/O Kumar Saibo of Uttar Palash, PO-Champasari, PS-Pradhannagar, Dist- Darjeeling under arrest along with the following articles seized articles viz:

- I. One iron made Sharp cutting steel made knife measuring approx. 8 inches (approx.) in length seized from the possession of Goutam Roy which was kept concealed on his back side.
- II. One iron made sword measuring 29 inch (approx.) including wooden butt seized from the possession of Gobinda Roy which was kept concealed on his back side,
- III. One iron made 'Khukri' measuring 17 inch (approx.) seized from the possession of Uday Singh which he was carrying on his left hand.
- IV. One iron made weapon locally called as "Bhojali" measuring 18 inches (approx.) seized from the possession of Biru Saibo.

I, SI Agen Lepcha of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted 04 (four) arrested accused persons namely (i) Goutam Roy (M-26) S/O Kamal Roy of Champasari Anchal Govindanagar, PO- Champasari, PS-Pradhannagar, Dist. Darjeeling, (ii) Gobinda Roy (M-22) S/O, Kamal Roy of Champasari Anchal Govindanagar, PO- Champasari, PS-Pradhannagar, Dist. Darjeeling (iii) Uday Singh (M-18) S/O Sunil Singh of Middle Palash, PO- Champasari, PS-Pradhannagar, Dist- Darjeeling and (iv) Biru Saibo (M-24) S/O Kumar Saibo of Uttar Palash, PO-Champasari, PS-Pradhannagar, Dist- Darjeeling and another 07/08 unknown involved accused persons to the effect that today on 30/01/2024 at 00:05 hrs., I received a source information that 11/12 youths have assembled at the playground of Amiyo Pal Choudhury School with deadly weapons and making preparation for committing dacoity in a house at Debidanga area. Accordingly, I informed the matter to the I/C, Pradhan Nagar PS and diarized the fact in General diary vide Pradhan Nagar PS GDE No 1524 dated 30/01/2024. After getting the permission from the I/C, Pradhan Nagar PS, I along with ASI Biplab Kumar Das, C/543 P. Rishi, C/735 S. Sarkar, C/873 S. Biswas and C/880 S. Dutta all of Pradhan Nagar PS left for Amiyo Pal Choudhury School; Debidanga to verify the veracity of the information. Under these circumstances any search warrant or authorization for search cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender. On the way to Amiyo Pal Choudhury School Debidanga, I requested night RT van officer PSI Bandhan Roy to come at Debidanga to accompany with us for holding raid at Amiyo Pal Choudhury School's playground. At about 00:45 hrs. we reached near Amiyo Pal Choudhury School and after a while time PSI Bandhan Roy along with his forces also arrived at the spot. I accordingly contact with my source and as pointed by the source we noticed that 11/12 persons were assembled in a dark place at the ground of Amiyo Pal Choudhury School and were whispering in a very low voice. Then we cordoned the place very carefully with a strong reason to belief that they were preparing to commit some cognizable offence and started walking towards them. But seeing police personnel approaching towards them they tried to flee away. However on hot chase we managed to apprehend above noted four (04) accused persons with deadly weapons in their possession but 07/08 persons managed to flee away from the spot taking the advantage of darkness and open place. On being asked the detained persons disclosed their identity as noted above. On interrogation they give different statement in different time and failed to give any satisfactory reply for their presence in the middle of night with deadly weapons.



Finally, they disclosed that they along with their associates had assembled there and were making preparation for committing dacoity in a house at Debidanga area. Accordingly, I seized the above-mentioned weapons of offence from their possession under proper seizure list duly signed by the witnesses and acknowledged by the accused persons and subsequently arrested them under proper memo of arrest and observing all the formalities of arrest. I accordingly brought all the four arrested accused persons along with seized article at Pradhan Nagar Police Station for further investigation. During interrogation it could be revealed from the arrested accused persons, that they had gathered there and were making preparation for committing dacoity in a house at Debidanga area. The whole process of seizure was made in between 01:05 hrs. to 02:00 hrs.

Under the above noted fact and circumstances, I therefore pray before you that a specific case under proper section of Law may kindly be started against the above noted arrested accused persons namely (i) Goutam Roy (M-26) S/O Kamal Roy of Champasari Anchal Govindanagar, PO- Champasari, PS-Pradhannagar, Dist. Darjeeling, (ii) Gobinda Roy (M-22) S/O, Kamal Roy, of Champasari Anchal Govindanagar, PO- Champasari, PS-Pradhannagar, Dist. Darjeeling (iii) Uday Singh (M-18) S/O Sunil Singh of Middle Palash, PO- Champasari, PS-Pradhannagar, Dist.- Darjeeling and (iv) Biru Saibo (M-24) S/O Kumar Saibo of Uttar Palash, PO-Champasari, PS-Pradhannagar, Dist.- Darjeeling and others 07/08 unknown miscreants and arrange for its investigation.
