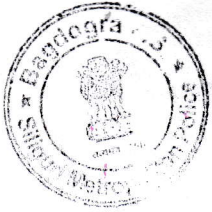

With referenece to the above mentioned subject I would like to inform you that, Yesterday around 7 P.M myself Nulkamal Halder son of Nityajopal Halder, resident of Chayanpara Siliguri, my wife Uma Dey, my baby Niharjo Halder and my 3 friends with family (Dipakamal Saha, Sumi Saha Dey, M-629781686, Sajib Karmakar, Sutapa Karmakar M-8392040350, Anubrata Bagchi M-7348938075, Dipa Pradhan M-9883693063) were coming back to Baidyogya from M.M Terai. One of the Guy having bike registration No. WB74AR3974 suddenly hitted our scooter registration NO. WB74BJ9447 near Bendubi from backside. Then we all me, my wife and my baby were falled down on the road. It is very surprising that after the accident he also teased my friend's wife Mrs. Sumi Saha Dey and Sutapa Karmakar. He also teased my friend Dipa Pradhan and she was injured. Then we left the scooter over there and somehow left that place. Then we came back to Baidyogya PHC. Now they have been admitted into Paramount hospital, Siliguri. They both under the CCU.

We need a solid action should take against WB74AR3974. I'm also enclosing his picture, bike registration No. and the Rx. of Baidyogya PHC.
