1. That SHOBHA BASFORE, wife of Sri. Umesh Basfore is my elder sister-in-law i.e. the elder sister of my wife who resides with her husband at NBMC & H Group D campus, Block A, room No. 4, P.O. Sushrutanagar, P.S. Matigara, Dist. Darjeeling which building is few meters away from my Block.
2. That 1. KRISHNA MALLICK, wife of Sri. Dinesh Kumar Mallick, (my mother-in-law) 2. BIJAY MALLICK (my elder brother-in-law) and 3. BIKASH MALLICK (my younger brother-in-law) both are sons of Sri. Dinesh Mallick, all of them also reside at NBMC & H Group D campus, Block C, room No. 8 & 11, P.O. Sushrutanagar, P.S. Matigara, Dist. Darjeeling which building is also meters away from my Block.
3. That since many years my above named In-laws, taking the benefit of being neighbours, have been creating unwanted interference in my family thus affecting the peace and harmony of marriage. Said BIJAY MALLICK and BIKASH MALLICK after consuming alcohol always creates ruckus in my block. I had even request my above named In-laws to not to disturb us but in vain
4. That on 28.01.2024 at about 9.30 P.M. said BIJAY MALLICK and BIAKSH MALLICK arrived my block on a drunken condition and was creating disturbance in my block. When I and my wife namely PRITI MALLICK requested to go back to their block as because my daughter was about to seat for annual exam in her school they to suddenly they became furious and started to assault me with fists and blows by saying that "we will kill you today". said SHOBHA BASFORE and KRISHNA MALLICK also arrived in my block and also assaulted me mercilessly with bamboo with the intend to kill me. On our shouting my elder brother namely AMAR MALLICK, son of Late Harihar Mallick, who resides at the different block but next to my building, arrived along with his family to rescue us but my above named In-Laws also attacked my elder brother and his wife with the intend to kill them. I received several injuries on my person specifically on my face. At present we are under treatment.

I therefore, request you to kindly take necessary stringent legal steps against 1. KRISHNA MALLICK, 2. BIJAY MALLICK, 3. BIKASH MALLICK and 4. SHOBHA BASFORE. I shall be obliged to you forever.
