This is for your kind information to the
concerned fact that on the 28th Day of January,
2024, Sunday at 11:30 P.M. (T.S.T). that a
turmoil had arisen at our quarter premises,
between our family members and that resulted
towards an occurrence of internal aggression,
causing a major hamper towards the peace
and tranquility of our area.

That, when I tried to stop the said aggression,
I was hurt grievously on the back-side of
my head, with a bamboo, by Amar Mallick and
Kanti Mallick and Ajay Mallick (3 miscreants).

And that as a consequence, I have suffered
grievous hurt, and that later, I was taken
admitted in the Emergency, where at that
moment, I got 3 stitches. And also, that I have
gone through a vital injury upon the finger
of my left-leg that was caused by those
3 miscreants, Ajay Mallick, Kanti Mallick
and Amar Mallick.

That till now, I am suffering severe body
aches and muscle pain, and that, I am also
quite unable to move freely. That at the
time of attack, these 3 miscreants were in
deep intoxication.

In view of the above stated facts and circumstances, that Your Honor would be graciously pleased, to enquire the matter properly and may take necessary action (legal action) against the said miscreants as it may be deemed fit and proper.
