**SUBJECT: COMPLAINT REGARDING THEFT**

Respected Sir/Madam,

I am writing to file a formal complaint regarding the theft at my residence, located at Venchi Jote, Patharghatta, under Matigara Police station on 30.01.2024. I regret to inform you that my house was burglarized, and several valuable items were stolen during the incident. The burglary took place somewhere around 1.0-5.0 a.m. The residents of the house (my wife and my niece) were at home in deep sleep when the unlawful activity was being carried out. Unfortunately, on 29.01.2024, I was not present in my residence as I was admitted to the hospital due to some health issues. On the morning of 30.01.2024, around 9.30 a.m., my niece informed me that the kitchen window was open and one bag containing the cash and the jewellery was missing. After searching for some time, my niece found the bag beside the residence. However, the cash and the jewellery were not present in the bag. I immediately contacted the authorities after getting discharged from the hospital, and I would like to request your department to initiate an investigation into this matter.

I am willing to provide the necessary assistance and information for the investigation.
