Subject: F.I.R.

I, Mrs. Harsimran Cheema, Wife of Mr. Amrit Pal Singh, residing at Flat No. 901 of Tower No. 8 The Residency, Uttarayon Township, Post Office and Police Station -Matigara, District -Darjeeling, PIN -734010, would like to inform you that on 29.12.2023 at about 18:15 hours, my son namely Master Nirvaan Singh Cheema aged about 9 years, came home crying and informed me that he along with his other friends namely Adarsh, Monit, Shivansh, Shreyash and Nitigya were abused by filthy languages and brutally assaulted at the park near the Tower No. 1 by two boys namely Ishaan and Abhinav who are residents of Flat Nos. 802 and 605 respectively of Tower No. 1. Those two boys dragged him to the Library under threat by showing an Air Pistol and threatening to fire upon him by that Air Pistol and thereupon Ishaan brutally assaulted him there which left several injury marks all over the face and body of my son including bruises under the eye. Thereafter, those two boys fired several rounds of pellets on him by that Air Pistol causing severe injuries to him. Then above named Abhinav & Ishaan compelled the other children present there in the park namely Monit, Shivansh, Adarsh, Shreyansh and Nitigya to assault my son by threatening them that otherwise those two boys will assault them badly and under such grave threats of those two boys some children were forced to badly abuse my son by hitting him on his face, chest and on his head. Then, Ishaan and Abhinav made forceful attempts to force my son to smoke a half brunt cigarette with warning not to disclose the incident to anyone.

Upon coming to know about the aforesaid incident from my son, I was utterly shocked and got severely traumatized, however, immediately I along with one Pinky Sarkar i.e., the mother of Adarsh who is also a resident of The Residency, informed the Security -in -Charge of The Residency regarding the said incident and about the firing by those two boys by the Air Pistol. Sometime later when we inquired about the said incident from the parents of the other children, namely Saumya Ojha i.e., mother of Shivansh, Sneha Anand i.e., mother of Monit, Swati Bhagat i.e., mother of Shriyansh and Shweta Bala i.e., mother at Nitigya Singh, all of them confirmed us that they have also heard the same from their respective wards.

Thereupon, on 2nd January, 2024 we all submitted a written complaint narrating the entire incident with the Administrator of our society for appropriate action, to which the administrator assured us to initiate appropriate action.

To our dismay, again on 3rd January, 2024 at about 18:00 hours, my child along with the above named other children (his friends) were brutally assaulted by Mrs. Binny Jaiswal i.e., the mother of Ishaan and Mrs. Chanda Sah i.e., the mother of Abhinav. On that fateful day, Mrs. Binny Jaiswal and Mrs. Chanda Sah, with the help of those two boys, forcibly dragged my son and his above named friends from the park to the office of Society and illegally and unlawfully detained and confined them there for almost an hour, without our knowledge and consent. My son was forcefully dragged and manhandled by Mrs. Binny Jaiswal and Mrs. Chanda Sah which is evident from the CCTV footage, which we later came to know. Thereafter, in a meeting scheduled on 4th January, 2024 at about 19:00 hours, above named Binny Jaiswal and Chanda Sah threatened me with dire consequences not to initiate any action against them.

I was shocked and traumatized to such extent that for past few days I was compelled to confine and isolate myself and my son inside our flat under the threat of injury to our life and limbs, which has caused some delay in lodging this instant complaint. After recovering from the trauma to some extent, I am lodging this instant complaint thereby requesting you to do the needful to set the law of the land in motion, to impart us justice.
