I have a private car, registration number WB74BB5231, and I hired a driver named MD Sahil @ Chotu son of address Vill- Tegharia near Oriental School PS+PO- Kishanganj, Dist- Kishanganj, Bihar-855107. who has been working from six months. Recently, I travelled to Bihar for 15 days and left my driver at my home, located at Kadamtala AH 2 near Durga Mandir PS. Matigara, Dist. Darjeeling, WB-734011.

Upon returning, I couldn't reach my driver as his phone was off. I tried reaching out to him multiple times later I learned from his neighbour that he was at his house. I discovered that my Oppo smartphone, Price 13500/- and 18,000 in cash were missing. When I sent someone to confront him at his residence, he refused to return the items and was dismissive.

I request your urgent intervention in this matter.
