In producing herewith (04) four arrested accused persons namely (i) Md Budha (30) S/O Md Sk Hafijuddin of Mallaguri, Ratanlal Busty, W/No. 01, PS-Pradhan Nagar, Dist. Darjeeling, (ii) Gopal Karmakar (22) S/O Lt Bimal Karmakar of Pati Colony, Road No-02, Gate Bazar, PS- Pradhan Nagar, Dist. Darjeeling (iii) Md Mustafa (22) S/O Md Moukim of Ratanlal Busty, W/No-01, PS- Pradhan Nagar, Dist. Darjeeling, (iv) Kunal Paswan (21) S/O Lt Dilip Paswan of Check Post, Paswan Busty, PS- Bhaktinagar, Dist. Jalpaiguri under arrest and the following articles seized articles. The ground of arrest duly been communicated with them.

- (1) One iron made sword measuring 30 inch (approx) in length including its wooden butt recovered and seized from the possession of accused Md Budha.
- (2) One iron made sword measuring 28 inch (approx) in length including wooden butt recovered and seized from the possession of accd Gopal Karmakar.
- (3) One iron made breaking instruments locally called as "PLUS" and one sabol measuring 14 inches in length from the possession of Md. Mustafa.
- (4) One iron made weapon locally called as "Bhojali" measuring 18 inch (approx.) in length recovered and seized from the possession of accd Kunal Paswan.

I, SI Bandhan Roy of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted 04 (Four) arrested accused persons namely (i) Md Budha (30) S/O Md Sk Hafijuddin of Mallaguri, Ratanlal Busty, W/No. 01, PS-Pradhan Nagar, Dist. Darjeeling, (ii) Gopal Karmakar (22) S/O Lt Bimal Karmakar of Pati Colony, Road No-02, Gate Bazar, PS- Pradhan Nagar, Dist. Darjeeling (iii) Md Mustafa (22) S/O Md Moukim of Ratanlal Busty, W/No-01, PS- Pradhan Nagar, Dist. Darjeeling, (iv) Kunal Paswan (21) S/O Lt Dilip Paswan of Check Post, Paswan Busty, PS- Bhaktinagar, Dist. Jalpaiguri and another 05/06 unknown involve accused persons to the effect that today on 02.02.2024 at 00.25 hrs received a specific sources information that 11/12 youths have assembled at Coolipara, Below Mahananda Bridge under Pradhan Nagar PS, SPC with deadly weapons and making preparation for committing dacoity in Gurung Busty area. Accordingly, I informed the matter to the I/C, Pradhan Nagar PS and diarized the fact in General diary vide Pradhan Nagar PS GDE No. 58 dated 02.02.2024. After getting the permission from the I/C, Pradhan Nagar PS myself along with ASI Monoj Kr Roy, ASI Biplab Kr. Das C/1411 Ashok Roy, C/1413 Sujit Sarkar, C/1415 Chandan Basak and C/1416 Dilip Barman all of Pradhan Nagar PS left for Cooliepara, Below Mahananda Bridge under Pradhan Nagar PS to verify the veracity of the information. Under these circumstances any search warrant or authorization for search cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender. On the way I requested night RT van officer PSI Bhiswadeb Barman to come at Cooliepara, Below Mahananda Bridge under Pradhan Nagar PS with force to accompany with us for holding raid at Cooliepara, Below Mahananda Bridge.

At about 00.45 hrs we reached at Cooliepara, near Mahananda Bridge under Pradhan Nagar PS and after a few time PSI Bhiswadeb Barman along with his force arrived at the spot at Cooliepara, near Mahananda Bridge under Pradhan Nagar PS and I contact with my source and as pointed by the source we noticed that 11/12 persons were assembled in a dark place below Mahananda Bridge and they were whispering in a very low voice. We cordoned the place very carefully with a strong reason to believe that they were preparing to commit some cognizable offence and started walking towards them.

On seeing police personnel approaching towards them they tried to flee away from the spot but on hot chase we managed to apprehend above noted four (04) accused persons with deadly weapons in their possession but 05/06 persons managed to flee away from the spot taking the advantage of darkness and open place. On being asked they disclosed their identity as noted above. On interrogation they give different statement in different time and failed to give any satisfactory reply for their presence in the middle of night with deadly weapons. Finally they disclosed that they along with their associates were assembled there and making preparation for committing dacoity at Gurung Busty area. Accordingly, I seized the above mentioned weapon of offence from their possession under proper seizure list in between 01.25 hrs to 02.15 hrs duly signed by the witnesses and acknowledged by the accused persons and subsequently arrested them under proper memo of arrest and observing all the formalities of arrest. I accordingly brought all the four (04) arrested accused persons along with seized article at Pradhan Nagar Police Station for further investigation. During the course of interrogation it could be revealed from the arrested accused persons that they were assembled there and making preparation for committing dacoity at Gurung Busty area.

Under the above noted fact and circumstances, I therefore pray before you that a specific case under proper section of Law against may kindly be started against the above noted 04 (four) arrested accused persons namely (i) Md Budha (30) S/O Md Sk Hafijuddin of Mallaguri, Ratanlal Busty, W/No. 01, PS-Pradhan Nagar, Dist. Darjeeling, (ii) Gopal Karmakar (22) S/O Lt Bimal Karmakar of Pati Colony, Road No-02, Gate Bazar, PS- Pradhan Nagar, Dist. Darjeeling (iii) Md Mustafa (22) S/O Md Moukim of Ratanlal Busty, W/No-01, PS- Pradhan Nagar, Dist. Darjeeling, (iv) Kunal Paswan (21) S/O Lt Dilip Paswan of Check Post, Paswan Busty, PS- Bhaktinagar, Dist. Jalpaiguri and others 05/06 unknown miscreants and arrange for its investigation.
