In producing herewith one detained accused person namely Ayub Khan G (Male/63 yrs) s/o Gulam Kader, 19/9, Thayar Sahib Street, Ellis Road, Anna Salai, Chennai, Tamilnadu, 600002 along with the following seized articles, as per seizure list enclosed viz.:

I, the undersigned to submit that the above noted person was brought to BOI Bagdogra by authority of DRI Siliguri and Custom Bagdogra Airport as those agencies reportedly has inputs that the said person coming from Chennai to Bagdogra by flight no. 6E 6518 may in possession of some contraband items. During the search of his baggage by Custom/DRI officials no contraband item was found but one Canadian Passport No. (PP No. AY180045) along with some Indian documents (Voter ID and Aadhaar Card) were recovered from his possession. The Canadian Passport and Indian Voter ID were having different names but same image i.e Image of Ayub Khan G.


