Roshanlal Agarwal resident of "Om Palace" Ashrampara, Siliguri-734001, Dist Darjeeling, would like to draw your kind attention to the following facts that I am the owner of house Om Palace Building situated at the above mentioned address and one flat was sold by me to the above named Sanjay Agarwal in 2006. After that said Sanjay Agarwal purchased few flats out of total six (6) flats after 15 years. Now mine flat situated at the top floor of the said building and the complete ground floor having office in it and out of six, four parking space are mine with gatekeeper room. And also all water tanks and connections and sewage are provided by us under this building as per the building plan and my caretaker is residing with family since last 17 years in top floor of the building. Regularly Sanjay Agarwal and his son Aryan Agarwal and his security guard namely Shamsher Chhetri created pressure upon my driver cum caretaker and their family not to come to the said flat and kept threading them. But I never tell anything to Sanjay Agarwal thinking that one day everything will be okay.

But today at around 2 Pm when I was entering into my flat said Sanjay Agarwala mercilessly beaten me with lathi and uses filthy languages towards me , threatened me with dire consequences and also snatched my gold chain, watch and some cash which was in my pocket. When I tried to stop said Sanjay Agarwal threatened me by saying that if I lodge any complaint against him then he will kill me. Mr Sanjay Agarwal now not letting me enter me in my own property and he was locked the main gate and creating my people homeless and disrupting my security forcefully.

In view of above you are requested to take proper legal action to arrest the culprit as per law.
