Sir/Madam,  
I, Puja Singh Khali, wife of Bikash Gajmair, resident of Relli Road,  
Kalimpong, would like to lodge a written complaint against  
Kaushik Paul, s/o Harinath Paul, New Paul Dresses, Bidhan Market  
Siliguri.

On 02.02.2024 at around 7 P.M. I had visited New Paul Dresses  
at the Bidhan Market Siliguri for shopping with my mother Sumitra  
Khali and my daughter Sanvi Gajmair. During the visit at the shop,  
one of the shopkeepers Kaushik Paul by name s/o Harinath Paul all  
of a sudden started arguing with my mother Sumitra Khali. At the  
moment, I tried to calm down Kaushik Paul but Kaushik Paul  
physically assaulted me and slapped me on my left cheek  
resulting to severe pain in my left ear. This incident happened at the  
aforesaid shop in front of Harinath Paul, my mother Sumitra Khali,  
my daughter Sanvi Gajmair and other people present at the shop.

I, therefore, request you to kindly take necessary legal action  
against Kaushik Paul s/o Harinath Paul for physically assaulting  
me.
