[Sub: F.I.R against some unknown miscreants demanding extortion money]

Sir,

I, Kundan Kumar, Son of Late Dinesh Prasad Singh, resident of Rathod Niwas, Satyajit Nagar, Tea Auction Road, Mallaguri, Post Office and Police Station Pradhan Nagar, Siliguri, District Darjeeling would like to bring to your kind notice that I run a departmental store in the name and style "A TO Z DEPARTMENTAL STORE CUM GROCERY SHOP" situated at Ambari, District Jalpaiguri bearing all the licenses and approvals from appropriate Government Authorities.

Sir, the license and other approvals for my business has been issued by the appropriate Government Authorities after following and having been met all the necessary requirements for running my said business. However, on 20th January 2024, some unknown miscreants entered my said departmental shop and demanded huge amount of extortion money from me saying that in order to run my business, I should pay them the said huge sum of money otherwise they are not going to let me run my business.

Sir, time and again whenever I have opened my said shop, the unknown miscreants have repeatedly threatened and demanded huge sums of extortion money from me and when I have denied to pay them the huge sum of money, they have threatened to harm and even kill me if I do not pay them the extortion money.

Sir, I am living in a constant fear of the loss of my life and property as the said unknown miscreants are coming and demanding extortion money on a regular basis.

Sir, the above miscreants resist me to run my business without giving them the extortion amount and due to their resistance and threat, I was compelled to close my departmental store since 24th January, 2024 and I is sustaining huge loss and the Government also is losing its revenue due to the closure of my business.

In the above circumstances, I therefore, humbly prayed before you to look into the matter immediately for the ends of justice and resist the above persons to do such illegal acts and/or to take the law on their own hands.

Sir, I have tried to amicably settle the matter to avoid any litigation but it has failed and therefore, this delay of filing this F.I.R. be condoned.

I also pray to take necessary legal action against the above miscreants for the ends of justice. Hope your kind co-operation and need full action please.
