Respected Sir/Madam,

I, DIPESH MITTAL, Son of Sri Raj Kumar Mittal, resident of Radha Swami Niwas, 85/1, Shiv Mandir Road, Punjabi Para, Siliguri, P.O. & P.S. Siliguri, District - Darjeeling would like to state the following:

- That yesterday i.e., on 01.02.2024 at about 11:00 pm, I received a call from a known friend
  of mine that my brother, Mukesh Mittal, Son of Sri Om Prakash Mittal along with his Wife
  Smt. Shalu Mittal and his friends have been hit by Car at Sevoke Road, infront of Paan
  Palace, Siliguri and was taken to the nearby Anandaloke Nursing Home.
- 2. That immediately, I rushed to Anandaloke Nursing Home after reaching, attending Doctors informed me that my brother, Mukesh Mittal, Son of Sri Om Prakash Mittal was dead and his friend Ajay Kesari, is critically injured and is still under observation.
- 3. Thereafter, on enquiry from the viewers, it could be learnt that the Four Wheeler Maruti Suzuki Breeza, bearing number WB 74 AS 1117 suddenly came at an excessive speed, recklessly and negligently hit the Car, bearing registered No. bearing No. WB 74 BN 7316 of my brother namely, Mukesh Mittal and his friend's Car, bearing No. bearing No. WB 74 BB 4689 (Satya Smriti Memorial Trust) intentionally with the intention to kill them.
- 4. That it also came to my knowledge that there were 3 (Three) persons inside the Four Wheeler Maruti Suzuki Breeza, bearing number WB 74 AS 1117 and these people came crawled out of their Car and fled away from the spot leaving by brother dead on the road.
- 5. Sir, I am willing to cooperate fully in the investigation that may follow and provide any further information as required in this case.
