Respected Sir,

I, **MISS RIYA CHOUDHURY**, Daughter of Prosenjit Choudhury, resident of Amtala, Chayan Para, Ward No. 37 of S.M.C., P.S. Bhaktinagar, Dist. Jalpaiguri beg to state as follows :-

On 21-11-2001 my parents namely Prosenjit Choudhury i.e. my father and my mother namely Dipali Choudhury Saha (Now Deceased) got married and thereafter in the year 2010 the said marriage had been duly registered before the concerned Marriage Registrar on 08-10-2010 Certificate being No. 64/2010 at Page 478 and We used to live at a rented house and for the last 3 years We used to live at the above addressed owned house. My above parents, I along with my only sister namely 1) Alisha Singh Choudhury (Now married and residing at her matrimonial house at Uttar Pradesh), wife of Vikram Singh, and 2) brothers namely 1) Rakesh Choudhury, 2) Jeet Choudhury used to live therein. My above father used to live 2-3 days of every month and used to pass days out of home for his land/property relating business purpose as always told by him and it is right place to mention here that he is a habitual drunker who used to consume alcohol under regular basis. Under usual manner on 26-01-2024 my said father arrived at house and under common manner started to reside at house by consuming alcohol under continuous manner. On 28-01-2024 at around 11.30 PM my above deceased mother for her own usage, accessed the mobile of my father and from his photo gallery, she found that my above father got married with another lady namely Sampa Biswas, Father name Debashish Biswas, resident of 1 No. Monishila Colony, P.O. Asansol-3, P.S. Asansol South, Dist. Paschim Bardhaman on 16-09-2020 and found too many joint close moment pictures and immediately my above deceased mother asked my said father about such issue, he started to address filthy languages to my mother, broke the phone and also physically assaulted her, thereafter on hearing my mother's shout, I along with my above brother rushed to their room and on our intervention my above father left the room with threatening to oust my mother along with us if my mother made any query about his other relationships and/or lifestyle, my above father also told desperately that he had the capacity to marry multiple girls of his choice who were in connection/relationship with him and thereafter my father went to asleep at the adjacent room of my mother alone. On the next morning i.e. on 29-01-2024 also, when my mother requested him to refrain from continuing said illicit relationship/s and asked him not to spoil the life of my said deceased mother and us, he again desperately threaten her to leave the house along with me and my brothers and also threatened not to maintain my above deceased mother and us and moreover threatened that my mother never able to do anything to him against his any ill deeds against her. My above mother also tried to make contact with the said Sampa Biswas who disallowed the words of my mother and thereafter on the said evening of 29th January, 2024, my father again under the alcoholic condition started mental torture upon my mother by using filthy languages and also blackmailed my mother by saying implicate her as well as us in false criminal proceedings by applying his influence/s. My mother got completely disturbed and on the next morning i.e. on 30-01-2024 at around 5.30 AM, out of repeated calls by my said father

when she did not open the door, my said father, brother (Rakesh Choudhury) broke the door and found my mother hanging on the ceiling fan and immediately We put her down with the help of surrounding people and found her death. Thereafter as per suggestion of local people, took initiative/s for shifting her body to Govt Hospital for post-mortem and on the said moment, my above father started to create pressure upon us for not moving my demised mother body for post-mortem and advised to do crematory rituals immediately which we denied and accordingly the post-mortem held on the said day at North Bengal Medical College and Hospital and crematory rituals completed on the very evening. Thereafter it came to our notice that my above father left our house and on repeated calls he just gave assurances to come soon and till date he did not bother to attend the house and fleeing away by giving false pretexts to us. It is my said father in active collaboration with the said Sampa Biswas who are responsible for my mother's death. Out of mental trauma, the delay caused to lodge this present complaint and now under stable mental position I have filed this present case.

It is therefore requested to your very end for treat this present complaint as specific case under strict penal provisions against the above 1) Prosenjit Choudhury and 2) Sampa Biswas and do the needful for the better administration of Justice.
