Sir,

I, SI Binup Mahato of NIP PS, Siliguri Police Commissionerate, do hereby lodge written complaint, on producing one arrested accused person namely Ajay Sarkar (55yrs) S/O Lt Biren Sarkar of Srinagar colony, Rana Sangha Matth, PS-New Jalpaiguri, Dist - Jalpaiguri under arrest along with following seized articles;

1. 15 (fifteen) Nos sealed Bottles of Himalayan Gold Country spirit 60 up, each bottle 600 ml, Marked as Exhibit A from which 01 bottles taken as sample for examination Marked as Exhibit-A1.

I am submitting a written complaint against the above noted accused person to the effect that today on 03.02.24 at 22-05 hrs received source information that one person was selling liquor illegally from his shop styled as Sumit Hotel at Basundhara Abason more, under New Jalpaiguri PS, Dist - Jalpaiguri to its customers without any valid license. Accordingly I informed the matter to the duty officer of NIP PS and O.C. NIP PS and as per his instruction myself alongwith C/453 Uttam Dey, C/152 Abdul Karim Mia, VP-13 Jamirul Islam all of NIP PS, SPC left for Basundhara Abason more to verify the veracity of information vide NIP PS GDE No. 184, Dated- 03.02.24. On arrival at the spot at 22-35 hrs it was found that one person mentioned above was selling liquor illegally from his shop styled as Sumit Hotel at Basundhara Abason more, under New Jalpaiguri PS to his designated customers to earn huge money for his livelihood. On seen the police party the customers as well as seller tried to flee away, but the seller was apprehended by police, on being asked he disclosed his name and address mentioned above. Thereafter in presence of witnesses I recovered the above noted articles from his possession from his shop and seized the same as per proper seizure list and labelled duly signed by him and also witnesses. On being asked the said person failed to produce any document or license for selling the liquor and confessed his guilt. As such I arrested the above noted accused person u/s 41 Cr.P.C. as it's a violation under Bengal Excise Act. The seizure & arrest was made in between 22.45 hrs to 23.20 (seizure Total approx 9 Ltrs).

Therefore, I request you to start a specific case under the proper section of law against one arrested person namely Ajay Sarkar (55yrs) S/O Lt Biren Sarkar of Srinagar colony, Rana Sangha Matth, PS-New Jalpaiguri, Dist.- Jalpaiguri and arrange for its investigation.
