Due to such dangerous attacks upon us by the accused persons my mother-in-law have sustain several serious injuries in the body and also in the head and so she has been taken by my husband to the Siliguri District Hospital.

That at about 9:00 p.m when there is no one in my house the above named accused persons again forcefully entered into my house with sharp sword and threatening and assaulting me and also pulling my kurti and trying to rape me and when I shouting my father came to the place and they left the place with threatening me that they kill my family.

Under the above circumstances it is humbly prayed to your good self to be kind enough to accept this F.I.R and to take necessary strict and vigil action against the above noted accused persons and to save us from the clutches of accused persons for the end of justice and also arrest the above noted accused persons immediately.
