In producing herewith one arrested accused person named Gourav Baraily (32 yrs) S/O Jiwan Baraily of Gandhi Gram, Ward No-10, PS- Kurseong, Dist.- Darjeeling under arrest along with following articles under proper seizure. The ground of arrest duly been communicated with him.

(i) 16 (sixteen) bottles TUBORG Premium Beer containing 650 ml in each bottle (Total 650 x 16 = 10.400 liters) and charked as Exhibit "A" out of which one bottle of the same taken as sample for examination and marked as Exhibit "A1".

(ii) 04 (four) bottles of Old Monk XXX Rum containing 180 ml in each bottle (Total 180 x 04 = .720 liters) and marked as Exhibit "B" out of which one bottle of the same taken as sample for examination and marked as Exhibit "B1".

(iii) 06 (six) bottles of Royal Stag Superior Whisky containing 180 ml in each bottle (Total 180 x 06 = 1.080 ltrs) and marked as Exhibit "C" out of which one bottle of the same taken as sample for examination and marked as Exhibit "C1".

I, ASI Monaj Kr Roy of Pradhan Nagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against the above noted arrested accused person named Gourav Baraily (32 yrs) S/O Jiwan Baraily of Gandhi Gram, Ward No-10, PS- Kurseong, Dist.- Darjeeling to the effect that today on 05.02.2024 at 17.05 hrs. I received a specific source information that one person named Gourav Baraily of Kurseong, is selling illicit liquor at his Restaurant styled as "JOLAR DEN" situated at Salbari Bazar under PS-Pradhan Nagar, Dist. Darjeeling without any valid license. Accordingly, I informed the matter to the I/C PS and diarized the fact in General Diary vide Pradhan Nagar PS GDE No 266, dated 05.02.2024 and as per his kind order and direction, I along with ASI Biplab Kr Das, C/1411 Ashok Roy, C/1413 Sujit Sarkar all of Pradhan Nagar PS left for Salbari Bazar to verify the veracity of source information. On reaching there and as identified by the source I along with other officers and force conducted raid at the Restaurant styled as "JOLAR DEN" of Salbari and managed to detain the owner of the said restaurant. On being asked he disclosed his identity as noted above and also disclosed that he is storing illicit liquor illegally at his restaurant to sale the same in higher price for his wrongful gain. On being search the above noted seized articles were found in his restaurant. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last 01 years for his illegal gain. Then, I seized and labeled the above mentioned illegal illicit distilled liquor under proper seizure list from his possession and subsequently, arrested the above mentioned detained person named Gourav Baraily (32 yrs) S/O Jiwan Baraily of Gandhi Gram, Ward No-10, PS- Kurseong, Dist.- Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 17.45 hrs to 18.35 hrs at the spot for violating the norms of Bengal Excise Act.

I, therefore pray before your good self that a specific case may kindly be initiated against accused Gourav Baraily (32 yrs) S/O Jiwan Baraily of Gandhi Gram, Ward No-10, PS- Kurseong, Dist.- Darjeeling Dist. Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
