I Md. Javed, the above noted complainant beg
to inform you that on dt. 05.02.2024 at about 01:00 am
in the midnight when my friends namely (1) Mukesh,
Kumar Mali (25) S/O Sri Hanstaram Mali, Permanent
resident of Vill-Mandawain, P.S-Ballut, Distt-Sirohi
Rajasthan-307801 and presently residing at Ghogroo-
mali, P.S-Bhakti Nagar, Distt-Jalpaiguri and (2) Mr.
Krishna Subari (29) S/O Sri Spandha Subari of Rajeswar
