Siliguri, at that time the following persons namely, (1) Md. Aman S/O Not known, resident of Thokkan, Khalibekhari P.S. Mithyura, Distt - Darjeeling, (2) Md. Chand S/O Not known of same address, along with others came to my shop & started abusing me in filthy language and when I protested they broken the beer bottle and hit on my head & severely injured me and stolen away Rs. 50,000/- (Rupees Fifty thousands) only and my mobile phone (Vivo 21) loaded with SIM card bearing contact no. 7501598989.

I immediately shifted to Siliguri Distt. Hospital and treated myself there.


The above noted alleged persons are very desperate & dangerous in nature and they have threatened me for dire consequences.
