In producing herewith arrested accused persons namely (i) Purna Biswas (24yrs) S/o- Lt Satya Rangan Biswas. of Sarbahara Colony W/No 28 .PO+Ps Siliguri Dist Darjeeling . arrested u/s- 41 Cr.P.C along with following seized articles viz: i) (Ten) Sealed Bottles Himalayan Gold premium 60 Up Country Spirit each containing 600 ML, each labeled as Himalayan Endeavour PVT Ltd. Siliguri, West Bengal @ Rs 120 each (Amounting of Rs. 120/-10=Rs 1220/-), in which one sealed bottle has taken from mother packet as sample under proper seizure list, labeling and memo of arrest.

1. ASI Suber Sen of Siliguri PS. of Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted accused person namely(i) Purna Biswas (24yrs) S/o- Lt Satya Rangan Biswas. of Sarbahara Colony W/No 28 .PO+Ps Siliguri Dist Darjeeling Sontu to the effect that on 05.02.24 at 20.15r hrs while performing Plain Cloth patrolling duty received a secret source information that the above noted person was busy to sale Id Liquor illegally at backside of of Sarbahara Colony W/No 28 .PO+Ps Siliguri Dist Darjeeling. in order to clandestinely dispose the same. Accordingly I informed the fact to IC Siliguri PS and as per his direction I along with other officer and forces left for Sarbo hara colony under Siliguri PS vide GDE no- 259/24 dated 05/02/24. On reaching at 20:15 hrs there and as identified by the source cordoned the above noted area where he was selling illegal alcohol. On seeing the police party the above noted person tried to escape from the spot but we manage to apprehend the above noted person and on interrogation he disclosed his identity as noted above. On being asked he stated that he used to sale the 60 up country Spirit to locality without any valid documents as he violated the norms of Bengal Excise Act for selling the said seized Liquor without any valid License. On search i) Ten (10) sealed bottles of Himalayan Gold 60 up country spirit each containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd .West Bengal @ Rs 120 each (amounting of RS 120/-10= Rs 1220/-) in which one sealed bottle has taken from mother packet box as sample as per seizure list which was kept concealed in a plastic bag. On being interrogation he could not produce any valid documents in respect of said liquor. He also stated that he is doing this Liquor business since long for his wrongful gain. Accordingly I seized the same in presence of witness duly signed by them. The seizure and label was made in between 20:45hrs to 21:10hrs. As such I arrested him U/S- 41 Cr. P.C after observing all legal formalities.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused person namely Purna Biswas (24yrs) S/o- Lt Satya Rangan Biswas. of Sarbohara Colony W/No 28 .PO+Ps Siliguri Dist Darjeeling .along with seized articles under proper section of law and arrange for its investigation.
