Sir,

In producing herewith one accused person namely Sambhu Roy (38), s/o- Lt. Sachin Roy of Tekatoli, near Tekatoli High School, PS-Mainaguri, Dist- Jalpaiguri, A/P- Durganagar Ward No.-40, PS Bhaktinagar, Dist Jalpaiguri along with following articles under proper seizure list :-

1. 12 (Twelve) bottles of "HIMALAYAN GOLD 60 UP COUNTRY SPIRIT" each bottle containing 600 ML, MRP Rs.155/- (Total-7.2 Liter & Amount Rs 1860/-) and marked as "Exhibit-A" out of which 01 (One) bottle taken as sample and marked as "Exhibit -A-1"

I, SI Agen Lepcha of Ashigarh Out Post , under Bhaktinagar Police Station SPC would like to lodge this written complaint against the above noted arrested accused person to the effect that today on 06/02/2024 at 20:05 hrs, I received a source information that one is selling liquor in his temporary tin shed shop situated at Ektiasal Haat under Ashigarh Out Post without any valid license.

Accordingly, the fact is diarized in General Diary vide Ashigarh Out Post GDE No 180, Dated 06/02/24 and shared the information with O/C Ashigarh OP and as per his kind direction I along with officer force had been to Ektiasah Haat under Ashigarh OP to verify the veracity of the information in hand. On reaching there and as identified by the source we held raid at temporary tin shed shop of the above noted accused and managed to apprehended him. On being asked he disclosed his identity as noted above and disclosed that he is selling illicit liquor at his temporary tin shed shop without any license for his wrongful gain. On further search the above noted seized articles were recovered from his tin shed shop. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last few months for his illegal gain. Then, I seized and labeled the above mentioned liquor under proper seizure list and arrested the above mentioned person named Rabin Sambhu Roy (38), s/o- Lt. Sachin Roy of Tekatoli, near Tekatoli High School, PS-Mainaguri, Dist- Jalpaiguri, A/P- Durganagar Ward No.-40, PS Bhaktinagar, Dist Jalpaiguri after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 20:25 hrs to 20:45 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your good self that a specific case may kindly be initiated against Sambhu Roy (38), s/o- Lt. Sachin Roy of Tekatoli, near Tekatoli High School, PS-Mainaguri, Dist- Jalpaiguri, A/P- Durganagar Ward No.-40, PS Bhaktinagar, Dist Jalpaiguri under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
