In producing herewith one arrested accused person named Bambam Mahato (27 yrs) S/O Ram Nihora Mahato of Near Lokhnath Mandir, Dagapur, PS- Pradhan Nagar, Dist.-Darjeeling under arrest along with following articles under proper seizure. The ground of arrest duly been communicated with him.

- 18 (Eighteen) bottles of 60 up Himalayan Gold India made liquor containing 600 ml in each bottle i.e. total (18 x 600) = 10.800 ltrs which was kept in a paper made cartoon and marked as Exhibit "A" out of which one bottle of the same taken as sample for examination and marked as Exhibit "A1".
- I, SI Bandhan Roy of Pradhan Nagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against the above noted arrested accused person named Bambam Mahato (27 yrs) S/O Ram Nihora Mahato of New Line, Dagapur, PS- Pradhan Nagar, Dist.- Darjeeling to the effect that today on 06.02.2024 at 22.35 hrs I received a specific source information that one person named Bambam Mahato of Dagapur is selling illicit liquor at his residence cum shop without any valid license. Accordingly, I informed the matter to the I/C PS and diarized the fact in General Diary vide Pradhan Nagar PS GDE No 338, dated 06.02.2024.

As per your kind order and direction, I along with ASI Biplab Kr Das, C/1411 Ashok Roy, C/1413 Sujit Sarkar all of Pradhan Nagar PS left for Dagapur near Lokhnath Mandir to verify the veracity of source information. On reaching there and as identified by the source I along with other officers and force conducted raid at the residence cum shop of Bambam and manage to apprehend him. On being asked he disclosed his identity as noted above and also disclosed that he is storing illicit liquor illegally at his shop to sale the same in higher price for his wrongful gain. On being search the above noted seized articles were found in his shop. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last 01 years for his illegal gain. Then, I seized and labelled the above mentioned illegal illicit distilled liquor under proper seizure list from his possession and subsequently, arrested the above mentioned detained person Bambam Mahato (27 yrs) S/O Ram Nihora Mahato of New Line, Dagapur, PS- Pradhan Nagar, Dist.-Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 22.55 hrs to 23.35 hrs at the spot for violating the norms of Bengal Excise Act.

I, therefore pray before your good self that a specific case may kindly be initiated against accused Bambam Mahato (27 yrs) S/O Ram Nihora Mahato of, Dagapur, PS-Pradhan Nagar, Dist.- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
