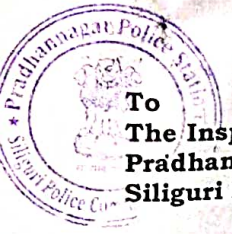

Sir,

With due respect and in producing herewith the following articles under proper seizure list :-

(i) - 16 (Sixteen) bottles of 60 up Himalayan Gold India made liquor containing 600 ml in each bottle i.e. total (16 x 600) = 9.600 ltrs which was kept in a paper made cartoon and marked as Exhibit "A" out of which one bottle of the same taken as sample for examination and marked as Exhibit "A1".

I, SI Goutram Mallik of Pradhan Nagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against accused namely Malin Roy (53 yrs) S/O Late Jogen Roy of Gurung Busty, Durga Nagar, Ward No-03, PS- Pradhan Nagar, Dist.- Darjeeling to the effect that on 07.02.24 at 19.35 hrs I received a specific source information that one person named Malin Roy of Gurung Busty, Durga Nagar is selling illicit liquor at his residence without any valid license. Accordingly, I informed the matter to the I/C Pradhan Nagar PS and diarized the fact in General Diary vide Pradhan Nagar PS GDE No 380, dated 07.02.2024 and as per his kind order and direction, I along with SI Bandhan Roy, ASI Biplab Kr Das, C/1411 Ashok Roy, C/1413 Sujit Sarkar all of Pradhan Nagar PS left for Durga Nagar, Gurung Busty to verify the veracity of source information. On reaching there and as identified by the source I along with other officers and force conducted raid at the house of accused Malin Roy of Durga Nagar, Gurung Busty under PS- Pradhan Nagar, Dist.- Darjeeling. But seeing the police party he managed to fled away from the back side window. We tried to apprehend him but in vain. On search the above noted seized articles were found in his residence. During enquiry it is learnt that one Malin Roy (53 yrs) S/O Late Jogen Roy of Gurung Busty, Durga Nagar, Ward No-03, PS- Pradhan Nagar, Dist.- Darjeeling is involved in selling and possessing of liquor without any valid license for last few days months for his wrongful gain. I searched every possible places to trace out the said accused Malin Roy but found he is absconding. Accordingly, I seized the above noted articles under proper seizure list in presence of witness. The whole process of seizure and label has been made in between 21.15 hrs to 22.05 hrs at the spot.

I, therefore pray before your good self that a specific case may kindly be initiated against accused Malin Roy (53 yrs) S/O Late Jogen Roy of Gurung Busty, Durga Nagar, Ward No-03, PS- Pradhan Nagar, Dist.- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
