**HANDING OVER OF TRESPASSER**

1. A trespasser named Mr. Mantu Roy aged approx 23 Yrs S/O Raja Roy resident of Vill-Sadarpur, Jagananthpur, Barasai Distt- North 24 Parganas West Bengal was apprehended at about 1300 hrs on 06 Feb 24 near KCC Plant (WT - 14) at Air Force Station Bagdogra by on duty air force personnel (DSC).
2. Preliminary inquiry reveals that suspected entered through broken Iron Grills over Hulia River near KCC plant (WT-14). The motive for entering defense installation could not be established. The Trespasser was wearing Black Hoodie, White check shirt, Blue T-shirt, Black Pant, Black Socks, and Light Grey Shoes. Following articles/ documents were found in his possession: -

  - (b) Metal Piece (Used in railway Track)


