In producing herewith one arrested accused person namely Kartick Oraon (31yrs) S/O- Balu Oraon of Karbala T.G, P.O+P.S- Banarhat Dist- Jalpaiguri C/O- Lata Rai W/O- Lt Sanu Rai of Salugara Bazar, P.O- Salugara, P.S Bhaktinagar, Dist-Jalpaiguri along with following articles under proper seizure list-

1] 12 (Twelve) bottles of HIMALAYAN GOLD 60 UP country spirit (each bottle containing 600ml)[Total 7200 ML/ 07 Ltr 200 ML]

I, SI Rantu Haldar S/O- Monoranjan Haldar of Bhaktinagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one namely Kartick Oraon (31yrs) to the effect that today on 08.02.2024, at about 17.40 received a source information that liquor selling is going on one fast food shop situated at Salugara Bazar under Bhaktinagar PS, without any valid license. Accordingly I informed the matter to the I/C PS and as per his kind direction myself along with ASI Chandra Prakash Adhikary, C/374 Debraj Biswas, C/912 Nakul Chandra Singha LC/1212 Nirita Lama left Ps at about 17.50hrs to Salugara Bazar under Bhaktinagar PS to verify the veracity of the information. This refers to Bhaktinagar PS GDE entry no.415, dated-08.02.2024. On reaching there and as identified by the source it found that one Kartick Oraon of the said shop was selling liquor. Subsequently, I along with officer and force cordoned the shop and was able to detain the above noted person but customers of the said shop got a chance and fled away. Subsequently on being asked the apprehended person disclosed his name and identity as noted above. Further being searched the above noted bottles of liquor were found from the said shop. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is the worker of the said shop and the owner of the said shop is Lata Rai W/O- Lt Sanu Rai of Salugara Bazar, P.O- Salugara, P.S-Bhaktinagar, Dist-Jalpaiguri. Then I seized the above mentioned liquor under proper seizure list in presence of available witnesses. The whole process of seizure has been made in between 18.45hrs hrs to 19.15 hrs at the spot. As he has violated the rules and norms of Bengal Excise Act hence I arrested the apprehended accused person namely Kartick Oraon (31yrs) S/O- Balu Oraon of Karbala T.G, P.O+P.S Banarhat Dist- Jalpaiguri C/O- Lata Rai W/O- Lt Sanu Rai of Salugara Bazar, P.O- Salugara, P.S-Bhaktinagar, Dist-Jalpaiguri after observing all sorts of formalities u/s 41 Cr.P.C appraising him the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Kartick Oraon (31yrs) S/O- Balu Oraon of Karbala T.G, P.O+P.S- Banarhat Dist- Jalpaiguri C/O- Lata Rai W/O- Lt Sanu Rai of Salugara Bazar, P.O- Salugara, P.S-Bhaktinagar, Dist-Jalpaiguri and also the owner of the said shop namely Lata Rai W/O- Lt Sanu Rai of Salugara Bazar, P.O- Salugara, P.S-Bhaktinagar, Dist-Jalpaiguri under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
