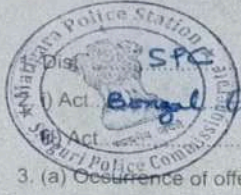


With due respect, I am producing herewith 01 (one) arrested accused person named John Toppo (45), S/o- Lt. Abraham Toppo of Bidhanpally, Shibmandir, PS- Matigara, Dist- Darjeeling under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 09 (nine) bottles of Himalayan Gold Country Spirit 60 UP (each bottle containing 600 ml and 5.4 ltr. in total).

I, ASI Pema Dorjee Sherrpa, presently attached with Matigara PS, SPC under your kind control beg to state that on 08.02.24, during my special night mobile van duty at Matigara PS area, at about 23.35 hrs, received an information that one person as noted above is selling ID liquor illegally from his house located at Bidhanpally, Shibmandir, PS- Matigara, Dist- Darjeeling. Accordingly, I inform the matter to you and as per your kind direction, myself along with C/219 Sanatan Chitrakar, C/523 Sanjit Kundu all of Matigara PS, SPC left for Bidhanpally under Matigara PS. At 23.55 hrs we arrived at Bidhanpally and as per indication by the source, found that the said person is selling ID liquor from his house for his illegal gain. During raid, the persons who were buying liquor were able to flee away from the house of the accused person. On demand he failed to produce any documents/license in respect of store/sale of the I/D liquor which were recovered from his possession. On being asked he disclosed his name and address as noted above. During interrogation he disclosed that he is selling ID liquor from his house for his illegal gain. Accordingly, I seized the above noted I/D liquor which were found from his possession under proper seizure list. Among the all 09 (nine) bottles, I took 01 (one) bottle as sample and marked as Exhibit-'A'. Then I arrested him under proper memo of arrest maintaining all the formalities of arrest. The whole process of search, seizure, label & arrest was made in between 00.05 hrs to 00.45 hrs on 09.02.2024.


